

## Implementation Status and Key Decisions

1. The project became effective on November 13, 2015. The SAPP Projects Advisory Unit (a new SAPP unit funded by this program) is staffed and up and running in Johannesburg. A number of activities are under way, especially in relation to procurement for regional analytical studies to be funded under this program (such as the update of the SAPP Regional Power Sector Masterplan). Additional donors have expressed strong interest in joining this program. SAPP utilities/member countries are expected to work with the SADC Secretariat/SAPP in the coming months to advance requests for funding to support preparation of regional priority projects.
