Implementation Status and Key Decisions

During April 7-17, 2015, a World Bank mission visited Guizhou Province to carry out the second Implementation Support Mission. The Project was approved by the World Bank Board of Directors on September 30, 2014 and became effective on March 9, 2015. It is too early to make an assessment of the project development objective achievement. However, the mission was impressed by the progress observed in organizing a number of strong farmer cooperatives proposing business and investment plans, which indicate innovative and promising examples of agricultural sector restructuring models showing a potential and likelihood of achieving the development objective of the project.

Most of the recommendations and actions proposed by the previous mission in November 2014 have been implemented. The leading groups and PMOs at all levels have been established. The province has set up a strong PPMO team, which provided field based guidance and training to local PMOs and project supporting staff at all levels including the organization of a study tour to one of more advanced counties. All project counties have started to identify and establish farmer cooperatives and prepared their first investment proposals. While several of the counties were found to have good understanding of the innovative concepts pursued under this project, the understanding of some of the counties is still mixed. Raising the understanding and changing the mindset in some of those counties remains a key task for the PPMO staff and provincial leaders.

Guizhou is the first among at least five provinces in China interested in using World Bank support implementing the new National Poverty Strategy of poverty reduction through industrialization, and other provinces are already looking at Guizhou's early experiences requesting to learn from them and come for study tours.

The next Bank implementation support mission is tentatively scheduled for September 2015. Prior to the mission, the provincial PMO and Bank team will discuss which counties would be visited based on the availability and status of the next round investment proposals.


