The development objective of the proposed operation is to strengthen the Government of Seychelles' Disaster Risk Management policy and reform agenda and enhance its capacity to efficiently respond to disasters.

Implementation Status and Key Decisions

The implementation status of the DPL with Cat DDO is satisfactory with regard to ongoing activities to strengthen the Disaster Risk Management framework.

In the context of strengthening the institutional and legal framework for disaster risk management, DRDM supported Anse Royale district on Mahé island and Praslin island to update their preparedness and response plans. DRDM conducted three annual drills in 2015 (two more than planned): two drills were related to Ebola virus and one related to oil spills. DRDM also conducted a various awareness campaign, one on disaster risk targeting policy makers, one for the general public and three topic specific ones; one related to pest control (hairy caterpillar), one on Ebola and one on the Zika virus.

In the context the integrating risk reduction into development planning and decision-making considerable progress has been made on the planning side. DRDM is represented at the technical planning committee of the Planning Authority hosted by the Seychelles Investment Bureau and participates in evaluating all development projects to ensure that risk information is included. For example, in the private sector, two recent major hotel projects inaugurated on Mahé conducted Environmental Impact Assessments that included risk information. Likewise, in the public sector, the Ministry of Land Use and Housing (MLUH) is updating the Town & Country Planning Act to include risk management, and is finalizing the Victoria Master Plan for urban development. Similarly the Ministry of Fisheries and Agriculture includes risk considerations when new land is leased out to farmers. MLUH and DRDM however also noted that the challenge remains in the supervision and enforcement of regulations of the implementation of

new developments.

Two activities did not reach their annual target and DRDM is taking measures to correct this during 2016. One activity is related to updating sector contingency plans for Education, Health, Industry and Tourism, the other activity to updating the geospatial data platform. The Presidential election and districts elections, coupled with changes of administrative staff contributed to the delays. In the case of the data platform also technical difficulties as well as the departure of one key DRDM staff also played a role in the delays.

DRDM is developing guidelines for emergency response for District Administrations and will train staff of the Community Development Department in application of these guidelines, this will ensure that district plans automatically will include protocols for preparedness and response. Three plans will be prepared for districts in Mahé in 2016. With regard to updating and adoption of sector contingency plans, DRDM will ensure that the updated Industry, Tourism and Education plans will be approved by the Cabinet of Ministers by the end of 2016. Currently the geospatial data platform is being revamped and is in the pilot phase of being tested and customized. Also a National Geospatial Working Group, with representatives of 14 organizations has been established and its members are being trained in the use of the geospatial data platform. The data platform is housed in and maintained by the GIS Unit of the MLUH and is planned to be up and running by September 2016.

Comments

The December 2015 target of updating two district protocols has been accomplished. Originally updates were expected for La Digue island and Beau Valon. The La Digue administrative organization is currently being restructured and in Beau Valon district council elections and a change in District Administrator, delayed updating the protocols. Instead protocols have been updated for Anse Royale district and Praslin island.

2016 Target: DRDM plans to develop guidelines for updating emergency response plans and train staff from the Community Development Department to support this, so that this becomes a routine task. As elections will be taking place for District Councils, a change of District Administrators is expected. District protocols will be gradually updated for Mahé island, first in the West, followed by the Central and then the South.

- 2015 target reached - The DRDM conducted 3 drills in 2015.

The December 2015 target was to conduct a full scale multi-hazard drill. Given importance of Ebola two specific drills were conducted: one desktop exercise to identify gaps, one training, and one simulation. The latter was in partnership with UN-OCHA.

Also an oil-spill exercise was conducted in June 2015, this is part of the European Union's capacity building effort in the Horn of Africa and the Western Indian Ocean (EUCAP-NESTOR).

The following exercises are planned for 2016:

- (i) April (26) test of the national emergency response plan, in liaison with British High Commission.
- (ii) September Indian Ocean Tsunami exercise (IOWave16), in partnership with Unesco.

One meeting was carried out at the National DRM Committee to sensitize policy-makers.

The theme for Disaster Risk Reduction day in October 2015 was: "Knowledge for life", the campaign included radio messages and a press release.

DRDM in partnership with the Ministry of Tourism and the Fire Brigade put forward an awareness campaign on fire risk for hotels and guesthouses.

DRDM carried out three other awareness campaigns in 2015, including for: (i) pest control (hairy caterpillar); (ii) Ebola, and; (iii) the Zika virus.

Furthering the DRDM positioning with the community, the agency website is currently under refurbishing, with the main goal of converting it into a risk reduction and awareness media outlet.
