## Implementation Status and Key Decisions

The Project was cleared by the Regional Vice President, as per ZIMREF Guidelines, on January 29, 2016, quickly followed by the signing of the Project and Grant Agreements on February 3, 2016. The Project has five conditions of effectiveness: (1) Recipient has established a Project Steering Committee, (2) the Project Implementing Entity has established the Project Implementation Unit. (3) the Project Implementing Entity has adopted the Project Implementation Manual, (4) the Subsidiary Agreement has been executed on behalf of the Recipient and the Project Implementing Agency, and (5) the Recipient and Project Implementing Agency must furnish an opinion or opinions satisfactory to the Bank of counsel acceptable to the Bank, showing on behalf of the Recipient and the PIE that the execution and delivery of the Grant Agreement and the Project Agreement on behalf of the Recipient and the PIE respectively, have been duly authorized or ratified by all necessary governmental and corporate action. On May 3, 2016, the period with which the Grant Agreements has to become effective was extended until August 3, 2016, since conditions of effectiveness (4) and (5) had not been met. However, the Subsidiary Agreement was subsequently signed on May 12, 2016, and so it is anticipated that the Legal Opinion(s) can be furnished by May 18, 2016, at which time the project can be declared effective.

Progress under Component 1 is satisfactory. The bidding documents for the first four growth center water and sanitation improvements are well underway, and it is anticipated that these can be finalized over the next couple of weeks to begin the procurement process. There have been some delays in making revisions to improve the documents and update the drawings.

Progress under Component 2 is satisfactory. Strong headway has been made in drafting the Terms of Reference for the National Water Resources Master Plan, and procurement has begun with the call for Expressions of Interest. There has also been progress on the Technical Assistance to the Local Authorities, in particular in developing the Terms of Reference for the Sanitation Needs Assessment. Less progress has been on the Technical Assistance for the Water Services Regulator, and on the Institutional Strengthening of ZINWA, and reasons for this will be explored during the first implementation support mission (planned for June 2016).
