# Notes to the Financial Statements

# 1. General Background:

The Justice Center for Legal Aid (JCLA) is a nongovernmental and nonprofit organization established in 2008 to provide legal counseling and legal representation services to the poor and the underprivileged in Jordan. The JCLA establishment came to reinforce the principles of legal empowerment of the poor and equal access to justice in line with national laws and international human rights agreements that support the principles of justice and equality.

Despite the gradual introduction of reforms, the judiciary bodies and legal services in Jordan are still underdeveloped, particularly with regards to services to the poorest communities. The Grant **"Enhancing Delivering Of Judicial Services to Poor Jordanians and Refugees In Host Communities Project** " project administrated by the World Bank to allow beneficiaries to improve access to fundamental social and economic rights, Including social protection, housing, personal status and employment-related matters and to ensure displaced Iraqis and Palestinians, and poor Jordanians, achieve more inclusion in the development and implementation of services.

In this context, the Justice Center for Legal Aid has signed an agreement with the International Bank for Reconstruction and Development (World Bank), to receive a grant for the extension of legal aid services in the amount of (USD 238.447.10) for Enhancing Delivering Of Judicial Services to Poor Jordanians and Refugees In Host Communities Project

As per the Grant agreement, the World Bank's Grant No. TF2524 in the amount of (USD 838.447.10) will finance the project "Enhancing Delivering Of Judicial Services to Poor Jordanians and Refugees In Host Communities Project" as per the categories showed in the following table:
