

## AIDE MEMOIRE

### 2026 Sovereign Guaranteed Operations

On November 12<sup>th</sup>, 2025, a bilateral meeting was held between the authorities of the Government of The Bahamas and officials of the Inter-American Development Bank (IDB), to review and agree next steps with respect to the programming of Sovereign Guaranteed (SG) operations for the year 2026.

#### I. Participants

The meeting was attended by the following key officials:

- **Ministry of Economic Affairs:** Michael Halkitis, IDB Governor and Minister of Economic Affairs; Simon Wilson, Financial Secretary, Ministry of Finance; Janice Miller, Permanent Secretary, Ministry of Finance; Carl Oliver, Deputy Director – Economic Planning, Ministry of Finance; Nathaniel Beneby, Advisor- Office of the Prime Minister.
- **Inter-American Development Bank:** Anton Edmunds, General Manager, Shirley Gayle, Country Representative, Steven Collins, Chief of Operations and Jose Luis Saboin, Country Economist.

#### II. Topics covered

**General:**

- (i) The importance of the long-term partnership of the Country with the Bank and the success of the 2025 program with 3 approved projects.
- (ii) In addition to the outlined Sovereign Guarantee Program below, the Government expressed interest in exploring opportunities of supporting current efforts on Land Reform during 2026 with the goal of preparing an operation for 2027.

**The 2026 Sovereign Guarantee Program:**

- (i) During the meeting, the Government of The Bahamas confirmed its willingness to move forward with the following loan program for the year 2026:

\*Dependent on the availability of PBL space.

- (ii) The Bank is currently in discussion with GoBH for a reformulation of a current loan- BH-L1043- Climate Resilient Coastal Management and Infrastructure Program. This reformulation opens a new opportunity

for IDB Invest for the Junkanoo Breakwater. A formal request letter is needed to proceed with the reformulation.

**(iii) Other potential SG loans:**

- a. Education. Program to strengthen and support the accreditation of tertiary institutions: UB; BAMSI and BTVI.
- b. Telecommunications. Program to accelerate digital transformation and inclusive growth, there is potential for a loan to finance a comprehensive connectivity and data infrastructure program, in collaboration with URCA and MoEA.
- c. National Statistics. Based on success of the initial work supporting the BNSI with TC support, the IDB, in conjunction with the MoF, will design a program to strengthening the Institute through technology, human capital and enhanced physical facilities.

**(iv) Update on the ONE Caribbean regional program.** Mentioned the fifteen ONE Caribbean initiatives that The Bahamas currently benefits from and provided an update on the PPCM roadshow that was done in September. The Bank requested the Government's non objection to:

- a. Sector notes (Energy, Water, Transport and Telecommunications) for the National Infrastructure Investment Plans (NIIPs) TC and confirmation of the Working Group of Focal Points from the Government that will work with our Sector Specialists.
- b. Be included as a beneficiary in the Regional Technical Cooperation Projects that will be listed in the AM.
- c. Support that project administration be carried out by the IDB in recognition of the regional nature and scope of these initiatives.
- d. Proceed with engagement of selected private sector stakeholders in targeted capacity-building activities.

### **III. Technical Assistance Operations**

The Technical Cooperations (TCs) are being programmed to respond to the needs of The Bahamas. As the TC pipeline is complete, they will be aligned with the 2026 program and the priorities and commitments of the government and the country strategy.

Discussed the possibility of TCs to support:


- a. Housing: The Bahamas Sustainable Housing Preparation Fund
- b. Agriculture: Institutional Capacity for Agricultural Risk and Data Generation and Governance in The Bahamas
- c. Telecommunications: The Bahamas National Digital Infrastructure Plan
- d. Education: Strengthening Digital and Data-Driven Education Systems in The Bahamas
- e. Trade: Design and Implementation of a National Trade Strategy for The Bahamas: Building Economic Resilience and Improving Living Standards.
- f. Seven other TCs, as per Annex I.

### **IV. Agreements**

During the meeting the GOBH and the IDB discussed and agreed on several actions and activities to be carried out during 2026:

- The Government of The Bahamas agrees to the Investment Loan of \$50M: Program to Support sustainable Housing Solutions; and the Policy Based Loan: Bahamas Resilient and Inclusive Fiscal Strategy for Economic Growth .
- The Government of The Bahamas agrees to send the letter requesting the reformulation of BH-L1043.
- The Government of The Bahamas agrees to participate in the technical cooperations referenced on Annex I, and for the Bank to be the executing agency.
- The Bank requested and the Government of The Bahamas granted its non-objection to (i) be included as a beneficiary in the Regional Technical Cooperation projects listed below; (ii) support that project administration be carried out by the IDB in recognition of the regional nature and scope of these initiatives; and (iii) proceed with engagement of selected private sector stakeholders in targeted capacity-building activities.
  - RG-T4220: Fostering the Development of Sustainable and Resilient Infrastructure in The Caribbean Region (US\$1,950,000). In The Bahamas, the TC will support the preparation of Sectoral Notes to inform the Infrastructure Pillar of the NDP.
  - RG-T4863/RG-T4864 – ONE Safe Caribbean for Vulnerable Populations I and II (US\$1.8M): Enhancing protection and resilience for at-risk groups across the region.
  - RG-T4835 – Operationalization of the Project Preparation Coordinating Mechanism (PPCM) (US\$1M): Building institutional capacity to accelerate project readiness and execution.
  - RG-T4806 – Strengthening the Innovation and Investment Ecosystem (US\$300K): Supporting entrepreneurship, digital transformation, and investment facilitation.
  - RG-T4854 – Fiscal Challenges in the Caribbean: Demographic Changes and Fiscal Risks from State-Owned Enterprises (US\$500k): Advancing governance and performance of public enterprises.
  - SME Technical Assistance (US\$7M): We also seek your support to proceed with targeted capacity-building for high-growth SMEs, positioning them for equity and debt financing through the Caribbean Community Resilience Fund (CCRF).
- The Government of The Bahamas will provide a letter of request to the Bank to begin the preparation of the Housing operation.
