1. Background and Justification

- **1.1.** Established in 1959, the Inter-American Development Bank ("IDB" or "Bank") is the main source of multilateral financing for economic, social, and institutional development in Latin America and the Caribbean. It provides loans, grants, guarantees, policy advice, and technical assistance to the public and private sectors of its borrowing countries.
- 1.2. The Social Sector (SCL) is a multidisciplinary team convinced that investing in people is the way to improve lives and overcome the development challenges in Latin America and the Caribbean. Jointly with the countries in the region, the Social Sector formulates public policy solutions to reduce poverty and improve the delivery of education, work, social protection, and health services. The objective is to advance a more productive region, with equal opportunities for men and women, and greater inclusion of the most vulnerable groups.
- **1.3.** Poverty in Latin America and the Caribbean (LAC) had a sustained fall in the first part of the 21st century. It was halved from 2000 to 2023. While the pandemic set the region back 7 years in its progress, the region was back to a sustained poverty reduction path in just one year. Despite these gains, approximately 152 million people in the region still live in poverty, unable to meet their basic needs, underscoring the need for multisectoral approaches to address persistent poverty effectively.
- 1.4. In LAC, non-contributory cash transfer systems reach around 30% of the population, yet cover only about 55% of those in poverty and address just one-third of the poverty gap. Persistent gender gaps in employment, standing at 20.3 points in 2022, are linked to high rates of informal employment that lack social protections. Climate change and economic shocks, like COVID-19 further hinder poverty reduction by impacting food security, health, and infrastructure, exacerbating vulnerabilities. Meanwhile, aging populations in countries such as Barbados and Uruguay stress under-resourced long-term care systems, leaving older adults financially vulnerable. Migration driven by poverty compounds these challenges, as migrants often encounter barriers to accessing social services and economic opportunities in their destination countries, perpetuating poverty cycle.



- **1.5.** The new Institutional Strategy of the IDB Group renews its focus on the eradication of extreme poverty and the reduction of poverty overall, and the accompanying Impact Framework seeks to ensure that a significant proportion of IDB projects directly benefit populations in poverty.
- **1.6.** Within this context, it is essential to develop tools that enable precise targeting and analysis of how projects target the poor, making them readily accessible for Bank teams to accurately measure how the operations are targeting poverty. 2. Objectives

2.1. To develop a platform for Bank teams to facilitate the classification of projects regarding their poverty targeting. The platform should include a database of country poverty maps and predefined profiles of different groups according to their poverty level. The platform should allow Bank teams to input basic information and have a recommendation to classify their projects as poverty targeted or not.

3. Scope of Services

3.1. Develop a platform to facilitate the classification of projects regarding poverty targeting, using IDB accumulated information. Content included in the platform by the firm should be available in English, Spanish, and Portugues.

- **4.1.** Engage with the government stakeholders to design the platform and assess available data sources to ensure alignment with country-specific information needs

- **4.3.** Establish protocols for the integration of poverty maps and group profiles, ensuring that the platform remains accurate with data updates done within the Bank
- **4.4.** Development and document platform and tools with clear justification for the choices, including performance, scalability, robustness, and ease of use
- **4.5.** Conduct validation tests to confirm functionality, accuracy and usability before final deployment
- **4.6.** Conduct system security assessment and create a Standard Operating Procedure (SOP) including data handling, system security, and publication, maintenance protocols.
- **4.7.** Conduct user training for Bank staff with platform's features and provide ongoing support as needed
- **4.8.** Monitoring and reporting of activities to the IDB. Firm should provide monthly reports to IDB on progress

1. Background and Justification

- **1.1.** Established in 1959, the Inter-American Development Bank ("IDB" or "Bank") is the main source of multilateral financing for economic, social, and institutional development in Latin America and the Caribbean. It provides loans, grants, guarantees, policy advice, and technical assistance to the public and private sectors of its borrowing countries.
- **1.2.** The Social Sector (SCL) is a multidisciplinary team convinced that investing in people is the way to improve lives and overcome the development challenges in Latin America and the Caribbean. Jointly with the countries in the region, the Social Sector formulates public policy solutions to reduce poverty and improve the delivery of education, work, social protection, and health services. The objective is to advance a more productive region, with equal opportunities for men and women, and greater inclusion of the most vulnerable groups.
- 1.3. Poverty in Latin America and the Caribbean (LAC) had a sustained fall in the first part of the 21st century. It was halved from 2000 to 2023. While the pandemic set the region back 7 years in its progress, the region was back to a sustained poverty reduction path in just one year. Despite these gains, approximately 152 million people in the region still live in poverty, unable to meet their basic needs, underscoring the need for multisectoral approaches to address persistent poverty effectively.
- 1.4. In LAC, non-contributory cash transfer systems reach around 30% of the population, yet cover only about 55% of those in poverty and address just one-third of the poverty gap. Persistent gender gaps in employment, standing at 20.3 points in 2022, are linked to high rates of informal employment that lack social protections. Climate change and economic shocks, like COVID-19 further hinder poverty reduction by impacting food security, health, and infrastructure, exacerbating vulnerabilities. Meanwhile, aging populations in countries such as Barbados and Uruguay stress under-resourced long-term care systems, leaving older adults financially vulnerable. Migration driven by poverty compounds these challenges, as migrants often encounter barriers to accessing social services and economic opportunities in their destination countries, perpetuating poverty cycle.



- **1.5.** The new Institutional Strategy of the IDB Group renews its focus on the eradication of extreme poverty and the reduction of poverty overall, and the accompanying Impact Framework seeks to ensure that a significant proportion of IDB projects directly benefit populations in poverty.
- **1.6.** Within this context, it is essential to develop tools that enable precise targeting and analysis of how projects target the poor, making them readily accessible for Bank teams to accurately measure how the operations are targeting poverty. This includes refining guidelines for projects across different sectors to measure their degree of poverty targeting and developing complementary tools (e.g., poverty maps and survey analysis) to assist teams around the IDB in achieving a high degree of poverty targeting.
