## II. OBJECTIVE AND JUSTIFICATION

2.1 Given the increase in the global trade flows and the growing complexity of the international logistic chains, Customs Administrations have become key institutions to facilitate and secure trade, and collect revenue. In the last decade there has been substantial progress in the region due to internal reform initiatives, partnerships with the private sector and creation of collaboration networks in the implementation of trade facilitation and security measures at both the regional and global levels<sup>1</sup>. The WCO has

supported these efforts by strengthening regional institutions<sup>2</sup> and Customs capacities. The IDB as the leading development institution in the region has developed numerous Customs modernization programs and regional initiatives.<sup>3</sup>

- 2.2 Customs Administrations have made substantial efforts to implement good practices which have generated positive results. Despite the progress made, Customs processes in the region are still redundant<sup>4</sup>, labor intensive and expensive with an average of 18 days for exports and 20 days for imports, still well below the 10 and 11 days respectively for OECD countries.<sup>5</sup> These results are partially caused by systemic deficiencies in several areas of Customs Administrations such as strategic planning, inter-institutional collaboration (especially when it comes to exchanging information and establishing coordinated processes), risk management, training, and the diagnosis and evaluation of their own performance beyond the level of revenue collection, amongst others. The World Trade Organization (WTO) has recently agreed the "Agreement on Trade Facilitation" in the 9<sup>th</sup> Ministerial Meeting in Bali, which aims to expedite Customs procedure, improve effective revenue collection, and promote cooperation among Customs Administrations<sup>6</sup>. Customs of WTO member countries are obliged to implement this international standard. Hence, the objectives of this technical cooperation project (TC) are to support the strengthening of Customs Administrations in the region, and to create an intra-regional platform that enhances their cooperation and sharing of best practices while giving them opportunities to learn advanced methods and practices of Customs Administrations outside the region.
- 2.3 The Agreement on Trade Facilitation is noteworthy in that the key prerequisite for compliance with the agreement is not political will, but rather technical and institutional capacity. The IDB in collaboration with the WCO, WTO and other strategic partners has developed and is implementing a capacity-building program on integration that needs scaling up in the face of the needs of the region and the Bali Agreement, the largest area of which is trade facilitation and security. The present TC presents an opportunity for scaling up the Program's impact, engaging Japan, a country with the highest trade facilitation and security standards, and for high visibility for the Japan Fund, which has supported trade facilitation but has not yet been involved in these recent high-profile capacity-building efforts.
- 2.4 This TC is in line with the priority to support "Regional and Global Competitive Integration" set forth in the IDB's Report on the Ninth General Capital Increase of Resources (AB-2764) (GCI-9). This operation supports the efforts of the Bank and WCO in the region<sup>8</sup> in the framework of the MOU signed in March 2001<sup>9</sup> and the commitment of carrying out joint and coordinated actions in the Region.

#### III. DESCRIPTION OF ACTIVITIES AND OUTPUTS

- 3.1 **Component I: Support to strengthen the operational capacities of Customs Administrations.** The objective is to train Customs Administrations to design and implement modernization projects and processes. It is foreseen: (i) to support Customs and other relevant officials through the delivery of online tutored (courses) and facilitated (Communities of Practice) professional-technical programs for Customs procedures, risk management, and other related trade facilitation topics.<sup>10</sup>
- 3.2 Component II: Support to intra-regional collaboration among Customs Administrations. The objective is to provide a platform for exchanging best practices between Customs administrations which strengthens their operational capacities. It is foreseen: (i) to support and promote the creation of regional technical thematic networks by developing South-South cooperation initiatives, in areas such as risk management and authorized economic operator (AEO) to disseminate the knowledge already generated in the region; (ii) to support the participation of Customs representatives in regional forums, dialogues and technical committees within the LAC region and in capacity building activities with Japan Customs; and (iii) to support a regional operational plan of IDB/WCO<sup>11</sup> with thematic workshops and seminars.

Customs Administration in the region is involved in this TC. However, they are low because 1) the WTO Trade Facilitation Agreement that requires Customs Administration to implement its measures has unanimously agreed between the WTO members at the Ministerial level, 2) there are strong interests of these Customs in improving their technical capacities in order to comply with the WTO Agreement; and 3) the WCO, as the requesting entity, engages to cooperate with the IDB closely to implement this TC through the WCO Regional Office for Capacity Building (ROCB) and the Vice

Given these supports, the IDB serves as an executing agency in its role as a facilitator of knowledge and dialogue mechanisms and as an honest broker to mitigate the risks. Also, the political commitments confirmed by the WTO Agreement mitigate these risks.
