We refer to your message of 15 August 2023 to the European Investment Bank (EIB) requesting information regarding the project 'REN GREEN ENERGY LOAN' (20220667)[1]. We also refer to our acknowledgement of 16 August 2023.

Your request has been handled on the basis of the EIB Group Transparency Policy (EIB-TP)<sup>[2]</sup>.

In response to your question, please note that the project REN GREEN ENERGY LOAN is a multi-component investment programme comprising only electricity transmission schemes dispersed throughout Portugal with voltage levels ranging from 60 kV up to 400 kV.

The project is expected to increase the flexibility and resilience of the electricity grid in Portugal and enable the integration of additional Renewable Energy generation, thus contributing to long-term national and EU decarbonisation targets, and it will help the promoter to maintain the reliability and quality standards of electricity supply in the country.
