

## Implementation Status and Key Decisions

This is the second ISR for this project which was approved by the Board on March 11, 2014 in the amount of \$18 million. The loan agreement has been signed on April 9, 2014 and the project is expected to become effective by March 5, 2015 after the Government requested for an extension of the Effectiveness Date. The closing date is May 31, 2019. The project has three components (i) Institutional Development to Improve the Business Climate; (ii) Support to Enterprise Development; and (iii) Project Management and Public Private Dialogue.

The project is not yet effective. A portfolio of 73 activities are planned by the time the Project becomes effective, 45% have already been completed (examples: legal workshops, recruitment of Business Plan Competition manager, Project Coordination Unit staff, items for the first phase of the Business Plan Competition, study tours, indegenous plan, environemental and social framework, operations manual, technical assistance for Doing Business reforms, manager for the Haut Conseil pour l'Investissement, etc.), 26% are currently being completed (examples: change management plan, assets assessment, human ressources assessement, recruitment of investment promotion specialist, ICT and legal advisors, trainers for Business Plan Competition prize winners, Doing Business action plan, etc.) and 29% still need to be completed (examples: ANPI-Gabon Business Plan, TORs for the construction of building at Chamber of commerce, industry studies, Women Business Center, etc.).

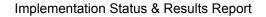

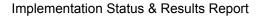


