AIDE MEMOIRE

Introduction

In response to the Government of Suriname (GoS) request to continue the preparation of the two policy-based programmatic loan series (PBL) "Public Expenditure Management III" and "Revenue Policy and Administration Reform II," a Bank orientation mission visited Paramaribo over the period of June 9-13, 2014. The mission team, led by Leslie Harper (IFD/FMM), was comprised of Rinia Terborg-Tel (FMP/CSU); Lucas Hoepel (CCB/CSU); Daniel Sanchez (IFD/FMM) and Peter Poulin (independent consultant).

The mission team held discussions with the following officials of the Ministry of Finance (MoF): Andojo Rusland, Minister of Finance; Liane Halfhide, Permanent Secretary of Finance; Cornelius A. van Dijk, Permanent Secretary of Taxes and Customs; Marita Wijnerman, Head Fiscal Affairs Indirect Taxes; Aruna Rampersad, Head Fiscal Affairs Direct Taxes; Joan Makhanlal-Veldhuizen, Inspector Direct Taxes; Glenn Kartopawiro, Customs Official; Charmaine Felter Chairman of the Rekenkamer; Reggie Resida Chairman of the CLAD; Cinthia Ramdin, Senior Sector Coordinator of Development Finance; and Sagita Jaggan, Coordinator Joint Desk.

In addition, a meeting was held with the Vice President of Suriname, Robert Ameerali and e-Government Chairman, Rahid Doekhie to discuss advances being carried out by the Cabinet of the Vice President in the area of e-transactions and electronic government procurement (e-GP).

Acknowledgement

On behalf of the Bank, the mission team would like to acknowledge the work that the officials of the GoS have been carrying out regarding these two important reforms. Progress in both revenue and expenditure functions was evidenced in the majority of activities identified since the IDB Team's last mission in February, 2014.

Mission activities

With regard to the two programmatic loan series the mission team together with the authorities from the MoF:

 Reviewed the status of conditions and their estimated completion dates for the two programmatic series SU-L1040 and SU-L1029. Reached agreement on main activities for technical cooperation program SU-T1069 that supports both operations and is currently under preparation.

Results

The mission had the following results related to the programmatic loan series "Revenue Policy and Administration Reform II" (SU-L1040):

- The GoS and the Bank established a timeline for completion for each individual condition (see follow-up table attached).
- The GoS has indicated that they will submit a legislative package to the Council of Ministers (COM) in July 2014, with the objective of submitting it to State Council (SC) after approval. The submission of the legislative package is key, as it includes multiple policy conditions of the PBL operation.
- The MoF and the Bank agreed on the specific activities for the technical assistance program under preparation. The MoF requested that the Bank execute the program, as the DoTC would rather concentrate on the technical aspects of the project that are directly related to the reforms being carried-out and ease the administrative burden they have.
- The GoS requested IDB support to finance technical visits from CIAT specialists to review technical specifications for a tax solution for the DoTC.

The mission had the following results related to the programmatic loan series "Public Expenditure Management III (SU-L1029)":

- The MoF informed the Bank that the GoS has decided to take a different approach to procurement reform and include the critical aspects for public procurement in the Budget Law and the e-Transactions Law, rather than in dedicated procurement legislation. The MoF and the e-Government Office within the Cabinet of the Vice President agreed to provide copies of the aforementioned draft laws for IDB review.
- The Bank, based on the above, has committed to provide the MoF with recommendation for articles to be included in the Budget Law in order to reflect best practices in public procurement (value for money, accountability and fair competition).
- The GoS has indicated that they will submit a Budget Law to Parliament in October 2014. The submission of the Act is key, as it includes multiple policy conditions of the PBL operation.
