Implementation Status and Key Decisions

- 1. The project became effective on May 1, 2015, and a number of activities have been completed or in progress.
- 2. PNG implementing partners attended a South-South learning tour in Suva, Fiji from May 25-30, 2016 to learn about regional best practice models in addressing FSV. The World Bank's Global Platform on Addressing Sexual and Gender Based Violence in Fragile and Conflict-affected Situations (FCS) organized the learning tour.
- 3 . A Type 2 re-structuring package is being prepared to re-structure the budget of the project to accommodate the purchase of a new vehicle to support project implementation activities.
- 4. The project has recently hired a highly qualified project management consultant to run activities in PNG.

The project has begun vetting organizations to conduct formative research (Under Component 1) on the drivers of FSV in EI communities in PNG and identify - based on global and regional expertise - community-level approaches to FSV being employed in the country, region (for instance, by Fiji Women's Crisis Center) or other countries, which would be appropriate to pilot, to address causes of FSV in EI communities in PNG[DD1] [DD1]Unsure if this text is appropriately placed here of if it should go in the above section under "Key Issues and Actions for Management Attention"
