## Description:

The objective of this TC is to accelerate the digital transformation of education services in Latin America and the Caribbean. This will be achieved through the creation of tools that assist education systems in granting access to digital resources for everyone, while also ensuring their effective use to enhance learning outcomes and trajectories.

The specific objectives are: i) Support educational systems to design an equitable strategy for schools' digital access considering connectivity, devices, digital skills, and contents, tools and platforms and monitor their progress towards the goals set by the MoU with the World Bank; ii) Identify promising and responsible applications of AI in education being used in the region and assess their potential to improve learning.

For Colombia, the extended country strategy for Colombia 2019-2022 (GN-2972, CII/GN-402) prioritizes to improve the quality of education by reducing regional inequities between urban and rural areas and weaknesses in existing education infrastructure. For Ecuador, the country strategy 2022-2025 prioritizes improving learning and protecting pathways.
