## Implementation Status and Key Decisions

The project was approved on August 1, 2014 and became effective September 29th, 2014, disbursing the first tranche on October 23, 2014. The project core team is in place and recruitment of consultants to support the work and handle procurement is underway or being finalized. As a result of the Ebola crisis, all schools have been closed for the time being and the emergency situation does not allow for an official project launch. The Project however is moving ahead with those activities feasible under the current environment, restructuring as needed to support the education response to Ebola, namely the radio programming and the reopening of schools. The full extent of the impact on the project will only become fully apparent once the crisis is over. At that time, there may be a need for further reprogramming and an extension of the closing date.






