Implementation Status and Key Decisions

Although approved in August and effective in October 2014, the project was only officially launched on August 6, 2015 due to Ebola driven delays and 8 months of school closures.

Activities are currently underway in all components, though some are moving faster than others. The Bank expects to undertake a mid-term review in the coming months to assess progress and explore, with the MEST, where/if modifications should take place. Although financial management and M&E have some challenges, overall project progress is moderately satisfactory and it is expected that implementation will be completed and objectives achieved.






