Implementation Status and Key Decisions

Implementation: Project disbursement has recently picked up momentum and is currently on track.

Business Environment: The Investment Climate / Doing Business reform program continues to progress, albeit slower than expected. The Project has succeeded to achieve positive results in the area of commercial justice reforms, as a result of a focused TA support to the Ministry of Justice. However, given that the Investment Climate Steering Committee (CCRCA) is not operational yet, a priority IC reform agenda for 2016 has not been approved. **Agribusiness**: Overall good progress has been made despite some delays due to insufficient coordination and delays in implementing the pre-agreed approach as to the mode of intervention for the different value chains. The Cotton value chain still poses a risk in term of results due to the uncertainties linked to the production of cotton seeds (Atsimo-Andrefana Growth pole). Similarly there are risks for the renewal and production of quality cocoa seeds (Diana Growth Pole). These challenges will require strengthening of research capacities linked to both value chains, in partnership with FOFIFA. It is still critical that the Government adopt a strategy for the cotton sector and provide capacity support to the cotton platform and for the enforcement of regulations. Detailed actions plans have been developed for both the Cotton and Cocoa value chains.

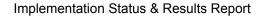
Tourism: The Project continues to engage in successful support of the tourism sector and identification of a strategic partnership to Air Madagascar. Key advisory positions are currently in the process of recruitment.

Improving services delivery and shared infrastructure: The Project has displayed consistent progress on fast-tracking infrastructure works contracts/activities, which represent 38% of total Project. (US\$19 million).

2. In Atsimo Andrefana, newly created jobs are mostly in services and trade sectors


In Anosy, the drop is explained by a massive exit in the sisal sector, following the current drought, as well as staff cutbacks in tourism sector.


