Implementation Status and Key Decisions

Implementation: The PIU office in Antananarivo and in the two regions (Anosy and Atsimo Andrefana), are fully staffed and operational. Project disbursement is on target at US\$ 5.53 million, or 12% of the IDA allocation. The second Project Steering Committee will be organized by January 2016. The project is working toward fulfilling its last two disbursement conditions.

Business Environment: The business environment reform agenda has been slow. While progress is made at the level of the technical groups the necessary political backing and approval at the Investment Climate Reform Committee are not taking place.

Improving services delivery and shared infrastructure: Works on urban roads and water have are on track but pending approval by the Bank of the Resettlement Action Plans (RAPs) and the confirmation of Government funds to pay for compensation linked to the RAPs. Final estimates on the compensation amounts are expected to be available by January 2016

Transfer of designated account to Central Bank: The GoM has adopted on October 27, 2015 a decree (Décret n°2015-1457) which will require that the project transfer its account to the Central Bank of Madagascar. To ensure that this change in operation of the project account does not create operational constraints and delays in disbursement a clear engagement of the Government with clear and effective measures must be in place before the project accounts are transferred


