This program will support two key priority results areas in Ukraine's basic education sector: (1) the New Ukrainian School (NUS) Reform of compulsory school education and (2) early childhood and preschool education. Within each of these key results areas, there are four strategic goals which are relevant to the Government program's theory of change and which will underlie the design of the PforR: (i) access to safe, modern and inclusive learning environments; (ii) quality of curricula and alignment with learner-centered and competency-based approaches to teaching and learning;

#### D. Environmental and Social Overview

#### **D.1 Overview of Environmental and Social Project Settings**

The project is nationwide in scope and takes place within the context of the Russian invasion of Ukraine. Since 2022, Russia's invasion of Ukraine has disrupted education due to damage to educational institutions and has deteriorated the quality of instruction due to teacher shortages and psychological pressure. As of November 2023, nearly 3,800 educational institutions (12 percent of the total) have been damaged or destroyed. Also, 43 percent of schools and 31 percent of preschools stopped providing in-person education due to the war. This represents a decline of 22 percent in the number of operating institutions and a 34 percent decrease in enrolled children since the beginning of the invasion in February 2022. Schools and preschools in oblasts under attack, such as Kharkivska or Khersonska oblasts, are solely providing online classes. This decrease is a loss for the children and their parents, especially mothers, who must care for them. The project is an IPF component of a broader Program for Results operation. The IPF component will support the improvement of learning conditions in schools, as part of the NUS reform, and preschools, and will create transparency and efficiency in monitoring subsidies.

The IPF component is comprised of technical assistance activities for capacity building, with minimal social impacts in themselves. The main risks are related to delivering in-person training activities in the context of the conflict. Other risks are related to ensuring that gender and social inclusion aspects are well incorporated into the training materials financed under the project, and that training for teachers is conducted in a safe and accessible environment.

At concept stage, the social and environmental risks are rated moderate given the risks of delivering in-person training activities in the context of the conflict.
