Implementation Status and Key Decisions

The second implementation support mission was conducted in Mauritania in May 9-17, 2016 and in Guinea in May 15-26, 2016. The overall progress towards achievement project objectives is Satisfactory in Mauritania and Moderately Satisfactory in Guinea, primarily due to slow implementation in the latter. In both countries, there is strong government ownership of the reforms required for stronger performance of the fishery sector. As the projects in both countries are still at an early stage of implementation (less than one year), the implementing agencies are fully up and running, and playing their coordination role.

The TOR for the cance census is already cleared and supposed to start in July 2016.


