Notice – Change of Trust Fund Number

Dear Ato Abdul-Aziz,

We refer to the Trust Fund Grant Agreement (the “Agreement”), dated July 17, 2014 between the Federal Democratic Republic of Ethiopia (“Recipient”) and the International Bank for Reconstruction and Development (“World Bank”) for the above-mentioned Project (the “Project”).

Due to a restructuring of the BioCarbon Fund Technical Assistance Trust Fund, the existing trust fund number TF017284 embedded in the legal documents for this Project (including, but not limited to, the disbursement letter of July 17, 2014) is replaced with the new trust fund number **TF0A2005**, effective from the date of this letter. All future correspondence regarding this Project should refer to the new trust fund number.

Except for the change in the trust fund number, all provisions of the Agreement shall remain in full force and effect.

We kindly request that the Government notify FAO in writing about the change in the trust fund number and forward us a copy of this notification for our records.
