The Stepping Up Skills Project was approved on September 30, 2014 and signed on October 6, 2014. The three effectiveness conditions were met on March 31, 2015. The effectiveness conditions were: (a) the adoption of the project manual, (b) the appointment of personnel for the Executive Secretariat, and, (c) the establishment of the competitive fund and of the competitive fund technical secretariat.

A PPA in the amount of US\$815,000 was made available to launch project preparation activities; of which a balance of US\$338,000 remains in the special account. Regular videoconferencing allowed the government and bank teams to keep the momentum during this period which was exacerbated by the Ebola outbreak. With the appointment of all key project staff, the team involved in project preparation handed over their responsibilities. On the Bank side, the TTLship has been handed over to a new TTL. An ETC is also in place in-country since early April to support the Bank team with the day to day monitoring of the project. A supervision mission is planned for September 2015. Status by component

Component 1: Fund for Skills and Employability

- 1. The Fund legal structure has been completed as well as the fund guide spelling out its governing principles.
- 2. 9 out of 10 contracts have been signed although one project facilitator has refused the offer. The candidate following the first ranked person will now be approached.
- 3. Although the 16 competitive fund board members have been recruited, they have yet to be nominated through a legal text (arrete). A draft is expected to be prepared by the end of May 2015. According to the legal agreement, the president of the board has to be someone from the private sector. Two options are being proposed for which a decision has to be taken: (1) proposal of three choices based on a predefined criteria to be submitted to the president of the COS for decision or (2) board members would be asked to prepare a program and present it to the board upon which the president would be elected.

Given the novelty of this type of fund in Guinea, a team will participate in a workshop on competitive funds to be held in June in Tunisia. 4. Component 2: Education to Employment (E2E) Program

- A survey of firms and training centers has been completed. The data needs to to be anlyzed to select those institutions/frms that should be 5. part of the E2E program.
- 6. The firm hired to support the AGUIPE's website and interconnection of databases in Conakry and the regions have completed their work. This is to be followed by the establishment of a registration process for unemployed youth to sign up.
- 7. An E2E opreational manuel has been finalized.
- 8. A field coordinator for the associated impact evaluation has not yet been recruited. A small team of three has been invited to a technical workshop in Cote-d'Ivoire to pursue discussions on design and methodology.

Component 3: Institutional Support and Regulatory Framework

- 9. The TORs for the Youth Observatory have been cleared and a workshop is to be held in May.
- 10. An Interministerial Commission for the revision of the regulatory framework consistent with current administrative, fiscal, and human resource reforms has been established. The modalities of the tasks and responsibilities falling under the commission in charge of the revision of texts will need to be better spelled out and planned. The commission has been asked to come up with a clear roadmap of activities and deadlines. The mobilization of the selected members remains problematic and should make use of the budget line that has been included in the project to follow this work.
- 11. National Quality assurance and Accreditation agency: A revised legal text was transmitted to the Bank which shows a reversal from the previous dialogue held between government and the bank over the past two years. Instead of an autonomous agency as agreed originally, it is now proposed that the agency become an attached unit to the Ministry. Moreover, TVET is no longer part of the plan. This poses considerable risks and is not aligned with international good practices. More in-depth discussions have to be pursued especially since the evaluation of the quality of programs is also being supported under the competitive fund. With the new approach taken by government, it would be very difficult to substantiate that the project should cover its set-up and operationalization.
- 12. Technical support for strengthening the information system of the higher education TVET institutions, as well as their respective Ministries is planned under the project. This activity has not started given the lack of a focal person from the Ministries assigned to this task.

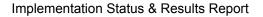
