Under preparation (i) compensatory rates to lessen motor vehicle use and add financial resources for sustainable transportation; (ii) regulation to promote tri-cycles is expected to be approved by December 2016; and (iii) legal-institutional framework regulations.

Results: Public transportation trips are being monitored and recorded. Methodologies for measuring non-motorized trips is under preparation. Per available public transportation trips percentages information, the *PND* target will be achieved, and it is the same in the DPL.

Definition of FENOGE's legal status to be defined by Decree before the end of 2016. IT2: FENOGE's Op. Manual will be issued by a Resolution of the Ministry of Mines and Energy, following Decree approval of FENOGE's institutional and legal structure. A draft of the Operational manual has already been completed. Results: FENOGE to be capitalized on time with COP 20 billion. It is likely that this target would be exceeded by the conclusion the programmatic DPO.

Follow up actions of Prior Action on DPL 1: MADS initiated work to widen Resolution 90063/2014 to include additional parameters for diesel fuel quality improvement. A study under way. During June 2016 is expected to be consulted with *OMC*. Regulation may be for approval by December 2016.

IT6: MADS initiated uniformity and updating process of Resolutions 1910/2008, 2604/2009 y 1111/2013 to rule vehicles emissions. Emissions norms to help reduce polluting units. Public Consultation to take place in August 2016. Approval of the Norm expected by December 2016.

ITT: MADS proposes stricter standards aiming to consolidate Resolutions 601/2006 y 610/2010. The Resolution process is expected to be finalized by December 2016.

IT5: MADS initiates Resolution 909/2008 updating process. A Study related to Emissions Permits standardization to reach wider participation. To be finalized in December 2016. MADS works in the Regulation development for 2017.

Indicator: Data is being collected and annual assessments are made. *MADS* is concerned about climate contingencies impact on concentrations of Particulate Matter above baseline levels. Chiefly in 2016. Consideration is being given to the relevance of the existing indicator to reflect the results of the reform. *MADS* inform the entry-in-service of 12 monitoring PM2.5 stations. Additional measures for pollutants reduction implemented in Aburra, like the "Pacto por la Calidad del Aire del Valle de Aburra," the "Plan de Descontaminación del Valle de Aburrá" and the "Protocolo de contaminación del aire".

IT8: MADS has worked in additional information collection to structure the Norm. MADS is preparing a Norm Proposal expected ready during first semester 2016. The Norm is expected to be approved by the end of 2016.

IT6: MADS informs that this Norm is under study and analysis as a priority for the PND and the Ministry. The Norm would be established by Decree.

IT7: MADS has taken stand in judiciary issues like Land definition. The Norm Proposal has been made. Concept framework has been designed and key sectors information has been gathered.

Results: MADS explained that the Norm about waste water discharges was effective since the beginning of 2016 and a first report will be issued in 2017. A 2014 Baseline is recorded. IDEAM is in charge of measurements that the CARs complete. MADS is carrying out a survey of 160 samples in 20 rivers.

IT8: This Norm is not being formulated since *MADS* is still working on the Norm of the Previous Action. Requests from other sectors have been received like the Car Washing and Lixiviates use in landfill activities.

Results: This Indicator may face some problems for its achievement adding to the hydrocarbon sector behavior and the specific geographic situation. GOC will establish a Baseline for this Indicator, which will be delivered prior to the preparation of DPL2. Baseline set up is pending.

MADS higligthed other efforts in regulating water usage. MADS is preparing a Decree that may be ready by November 2016.

IT9: Achievements in requirements definition for the use of alternative energies in sanitary landfills: Studies were over in May 2016 and the Resolution is being prepared, for approval in October 2016. Technical Standards Definition Consultancy got paused due to lack of funds. The World Bank will assist in exploring other financing options.

Results: To date 43.92% of the Municipalities have PĠIRS. Municipalities disposing trash in Sanitary Landfills number 966 surpassing the 916 target.
