Agreement for the Termination

of

the Administration Agreement

between

the Inter-American Development Bank

and

the Government of Switzerland, represented by the Swiss Agency for Development and Cooperation

regarding

a Non-reimbursable Grant Contribution to the Inter-American Development Bank

WHEREAS, the Government of Switzerland, represented by the Swiss Agency for Development and Cooperation (the "Government"), and the Inter-American Development Bank (the "Bank"), entered into an Administration Agreement for a non-reimbursable grant contribution to the Bank (the "Contribution"), which became effective on June 6, 2013 (the "Administration Agreement");

WHEREAS, Contribution funds have been administered by the Bank for the purposes described in the partnership program No. RG-X1176 titled, "Evaluation for Development Results in Latin America and the Caribbean" (the "Partnership") attached to the Administration Agreement (the "Annex"), for the benefit of the Bank's borrowing member countries in Latin America and the Caribbean;

WHEREAS, the Government and the Bank hereby wish to amicably terminate the Administration Agreement and the Partnership and transfer any remaining uncommitted Contribution funds to the Government, pursuant to paragraph 10 of the Administration Agreement.

NOW, THEREFORE, the Government and the Bank hereby agree as follows:

- 1. To deem the Administration Agreement and Partnership terminated as of March 31, 2016 (the "Termination Date").
- 2. The Government acknowledges that the Bank has fulfilled the reporting requirements contemplated under paragraph 3(a) (for the first and second installments of the Contribution) and paragraph 9 of the Administration Agreement, and paragraph 5.3 of the Annex. The Bank will provide no additional reporting to the Government.

- 3. Once all committed Contribution funds have been fully disbursed towards approved Partnership activities, any remaining uncommitted funds, including any amounts from cancellations, recuperations or otherwise pertaining to the Contribution, minus the earnings to be retained by the Bank, if any, will be returned to the Government by the Bank (as more specifically detailed in the attached 'Budget Execution Report').
- 4. For the avoidance of doubt, the Government and the Bank acknowledge that the Government has previously disbursed the first and second installments of the Contribution referred to in paragraph 3(a) of the Administration Agreement.
- 5. Except as otherwise described herein, the parties' rights and obligations with respect to the Contribution, the Partnership and under the Administration Agreement will cease as of the Termination Date.

IN WITNESS WHEREOF, the Government of Switzerland, represented by the Swiss Agency for Development and Cooperation, and the Inter-American Development Bank, each acting through its authorized representative, have signed this Termination Agreement in the English language as of the dates indicated below.
