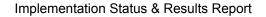






Implementation Status and Key Decisions

The Project was declared effective by the World Bank on January 20, 2016, and a Project Implementation Unit (PIU) was subsequently established within the National Institute of Education (NIE). The implementation of the Loan has been initiated with total disbursements of US\$ 0.225 million as of June 30, 2016. The first batch of school rehabilitation contracts is expected to be awarded in August-September 2016. By December 31, 2016, disbursements are expected to reach US\$ 7.968 million.

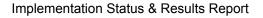




