***Re: Republic of Indonesia: FCPF Readiness Fund Grant
REDD+ Readiness Preparation
(Grant No. TF099721-ID)
Corrigendum to Grant Agreement***

We refer to the Grant Agreement dated June 10, 2011 between the Republic of Indonesia (the Recipient) and the International Bank for Reconstruction and Development (the World Bank), acting as Trustee of the Readiness Fund for the Forest Carbon Partnership Facility, for the above-referenced activity (the Agreement).

We note that, due to an oversight, the Agreement reflects certain minor errors; this corrigendum rectifies those errors.

1. Footnote 1 to the Agreement erroneously includes a reference to World Bank execution of certain related activities on behalf of the Recipient. Accordingly, the phrase "on behalf of the Recipient" in said provision is deleted, and said provision is revised to read as follows (emphasis added):


"¹ Pursuant to a request dated November 4, 2010 from the Recipient, the balance of four hundred three thousand five hundred seventy two United States Dollars (US\$403,572) is being made available as a grant from the Readiness Fund for the FCPF to the World Bank, acting in its own capacity and not as Trustee, for purposes of World Bank execution of certain activities relating to the carrying out of the R-PP as part of its work program."

2. Finally, Section 1.02 (m) of the Annex to the Agreement erroneously includes a reference to non-consulting services in the definition of training. Accordingly, the phrase "non-consulting services for purposes of" in said provision is deleted, and said provision is therefore revised to read as follows:

“(m) “Training” means the cost of training under the Readiness Preparation Activities, attributable to seminars, study tours, and workshops, and including domestic and international travel costs and subsistence allowances for training participants, costs associated with securing the services of trainers and speakers, rental of training facilities, preparation and reproduction of training materials, refreshments, and other costs directly related to training preparation and implementation.”

All other provisions of the Agreement, except as revised herein, remain unchanged.
