## **ENVIRONMENTAL AND SOCIAL COMMITMENT PLAN**

- 1. The Balkan Green Foundation (BGF) will implement the **Partnerships for Green Transition Project** (P179084) (the **Project**), with the involvement of the following two partner organizations: Lëvizja FOL (FOL) and Open Data Kosovo (ODK), as set out in the GPSA Grant Agreement. The International Bank for Reconstruction and Development (hereinafter the *Bank*), through the provision of a GPSA Grant, has agreed to provide financing for the Project.
- 2. The BGF will implement material measures and actions so that the Project is implemented in accordance with the Environmental and Social Standards (ESSs). This Environmental and Social Commitment Plan (ESCP) sets out material measures and actions, any specific documents or plans, as well as the timing for each of these.
- 3. The BGF is responsible for compliance with all requirements of the ESCP even when implementation of specific measures and actions is conducted by the other partner organizations or stakeholders.
- 4. Implementation of the material measures and actions set out in this ESCP will be monitored and reported to the *Bank* by the BGF as required by the ESCP and the conditions of the legal agreement, and the *Bank* will monitor and assess progress and completion of the material measures and actions throughout implementation of the Project.
- 5. As agreed by the *Bank* and the Balkan Green Foundation (BGF), this ESCP may be revised from time to time during Project implementation, to reflect adaptive management of Project changes and unforeseen circumstances or in response to Project performance conducted under the ESCP itself. Agreement on changes to the ESCP will be documented through the exchange of letters signed between the *Bank* and the BGF. The BGF shall promptly disclose the updated ESCP.
- 6. Where Project changes, unforeseen circumstances, or Project performance result in changes to the risks and impacts during Project implementation, the BGF shall provide additional funds, if needed, to implement actions and measures to address such risks and impacts, which may include environmental, labor, and health, and safety risks.
