


## Implementation Status and Key Decisions

This report follows the supervision mission carried out in September 2016.

The project was approved by the Bank's Board on June 11, 2015, signed on December 9, 2015 and became effective on April 7, 2016. Implementation delays are increasing due to the slow process of preparing participation agreements with Provincial Governments for signing, a condition for financing field activities.

Important advances in parallel include the preparation of provincial strategic plans, to guide implementation, and the organization of provincial implementation teams.

The next supervision mission is scheduled for March 2017.






