Heal to Grow: Emotional Wellbeing and Mental Health in Early Childhood

1. Background and Justification

- 1.1 It is imperative to understand the impact the COVID-19 pandemic has had on the mental health of students, caregivers, and teachers, and identify solutions to support young children. Against this background, the objective of the proposed TC is to design and evaluate a program to support the mental and emotional health of young children.
- 1.2 Background. The COVID-19 pandemic has brought unprecedented changes and challenges into the lives of people. Households throughout the world are suffering from the socio-economic impact of decreased or lost livelihoods, the loss of loved ones, and a decrease in social interactions which can all have a detrimental effect on mental health and well-being. For those involved in education, whether it be as students, teachers, or caregivers; the pandemic has been significantly challenging. The world changed overnight, and everyone was forced to adapt their learning environments and worry about each other's health and safety.
- 1.3 These quick changes to students' and families' daily lives took a toll on their mental health and well-being. A study by Vaillancourt (2021a) in the United States, shows that parents had significantly worse mental health than other adults. Additionally, since the pandemic began, research has shown that teachers have shown an increase in psychological symptoms, such as stress, anxiety, and depression (Ozamiz-Extebarria et al., 2021). The well-being of caregivers and teachers can also affect the well-being and academic performance of students. An IDB regional survey, including Colombia and other countries, finds that the COVID-19 pandemic and associated social distancing measures have substantially affected the mental health and well-being of young children and their caregivers. A vast majority of caregivers (85%) reported at least one symptom of deteriorated mental health during the pandemic. Findings show troubling gender gaps in reported deterioration of mental health outcomes with mothers of young children being more affected by the pandemic than fathers, including gender gaps in sadness (26.1%), lack of appetite (27.7%), overall distress (20.1%), fear (16.3%), exhaustion (18.4%), and insomnia (15.9%). Child distress was found to increase in tandem with caregiver distress. Caregivers reported increased symptoms of distress during the pandemic, with 61% of children displaying at least one symptom of mental distress (Näslund-Hadley et al. 2020). In response to this mental health challenge of young children, the IDB has supported the development and testing of socio-emotional learning and mental wellbeing models for preschoolers. In Nicaragua, an caregiver application to foster socioemotional learning and mental health of young children has been developed and is being experimentally evaluated (NI-T1294). In El Salvador, the Tuchan model to support child development and socioemotional learning was designed and experimentally evaluated (ES-T1295, EST1282). In Guatemala, a behavioral intervention has been designed and evaluated (RG-T2838). In Colombia, the Government has tested an international model, Think Equal, for fostering socioemotional skills (CO-T1524).
- 1.4 **Think Equal**. The socioemotional learning program Think Equal targets Colombian 4–5-year-old children, fostering socioemotional learning. The model was evaluated through an experimental



evaluation (IPA, 2022) to assess its impact on children's competencies in empathy, inclusion, compassion, problem-solving, critical thinking, collaboration, emotional regulation, generosity, and advocating and caring for others. The experimental evaluation showed that the Think Equal program had positive effects on children's prosocial behavior, emotional autoregulation, self-awareness, and cognitive learning. Treated children have higher cognitive development than their peers in the control group (0.15 standard deviations) and treated caregivers experience fewer negative emotions than controls (0.24 standard deviations). The program also improved mental health outcomes of caregivers (0.14 standard deviations) with effects being particularly elevated among caregivers with incomplete secondary education (0.22 standard deviations) (IPA, 2022).

- Heal to Grow. Based on the positive results from Think Equal on social emotional skills, the Government of Colombia has designed a program called Heal to Grow (Sanar para Crecer) which seeks to promote wellbeing of hundreds of thousands of young children and their caregivers. The program expands the Think Equal model by adding a second module to foster mental wellbeing. The program is implemented through the Colombian Institute for Family Wellbeing (ICBF) through a nationwide network of community households (HCB). HCBs are early care settings under the responsibility of a trained person for children from 6 months- 5 years of age. All the HCBs under ICBF serve about 1.7 million vulnerable children and their families nationwide. The program's goal is to promote the social emotional and mental health development of young children through strengthening the wellbeing of the HCB leads. The ICBF has contracted ten child psychologists who will lead the implementation of Heal to Grow, including the training of some 150 HCB educators.
- 1.6 Against this background, the IDB is looking to contract a consultancy firm to assist with the evaluation of the Heal to Grow program in Colombia and conduct a regional study.

2. Objectives

2.1 The objective of the proposed TC is to design and evaluate a program to support the mental and emotional health of young children; and conduct a comparative international study contrasting the results from Heal to Grow with regional initiatives that aim to foster mental health and socioemotional learning.

3. Scope of Services

3.1 The firm will develop an evaluation design of the program. The evaluation should encompass some 1,500 children. The regional study of mental health interventions should include at least three countries.

4. Key Activities

- 4.1. The consulting firm will carry out the following activities:
 - a. **Work Plan.** Create a Work Plan of the consultancy. The Plan must also include the elaboration and validation stages of the regional study, as well the experimental evaluation of Heal to Grow Program (it must contemplate and list the required elements for the different parts of the project).



- b. Sample and randomization design. Conduct the sampling and randomization.
- c. **IRB.** The approval of the trial by a certified Institutional Review Board (IRB) for Human subject research.
- d. Experimental evaluation. Evaluate the Heal to Grow program randomizing Community Households (HCB). The experimental design will contrast any changes in wellbeing of children in the treatment group (Group I) with children from a group of comparison community households (Group II). The collection of quantitative baseline and endline data, using the Children Behavior Checklist (CBCL) and the Family Care Indicators (FCI) and instruments used in the assessment of children's mental health used in the Think Equal evaluation and other countries.
- e. **Monitoring.** The firm must work closely with the IDB to maintain a detailed record on the implementation of pilot as well as the survey. Continuously meet with the IDB, to discuss the progress of the consultancy.
- f. **International Comparative Study:** Conduct an regional comparative study of socioemotional learning and mental wellbeing of interventions in the region.

5. Expected Outcome and Deliverables

- 5.1. The evaluation consultant will submit the following reports:
 - A detailed workplan
 - IRB
 - Sampling design
 - Randomization
 - A baseline report
 - A final experimental evaluation report, including database and codebook
 - International comparative study

6. Project Schedule and Milestones

- 6.1. The evaluation will take place between 2022 and 2025.
- 6.2. The international comparative study will be developed and disseminated between 2024 and 2025.

7. Reporting Requirements

7.1. Reports must be submitted in electronic files. The databases should be submitted in STATA and must include code books

8. Acceptance Criteria



- 8.1. Acceptance of consultancy products will be based on international practices for human subject research, and experimental evaluations.
- 8.2. The Bank will be responsible for reviewing and accepting the deliverables generated through the consultancy.

11. Schedule of Payments

The objective of the consultancy is to provide research support, including data analysis and drafting of an academic paper.

- (iii) Review edits and Spanish Translation of paper (2 days).
