Implementation Status and Key Decisions

The Social Safety Net Project has made substantial progress since its approval on March 25, 2014 and effectiveness on August 29, 2014. Despite challenges due to the Ebola Virus Disease (EVD) outbreak, the Project is on track to achieve its objectives. The Project has operationalized all the components activities, namely systems building, cash transfers, and project management and capacity building. The key systems elements operationalized include:

- 1. the three-stage targeting tools (geographical targeting, community-based targeting, and proxy means testing); the management information system (MIS) and integrated registry, the Social Protection Registry for Integrated National Targeting (SPRINT);
- 2. related operational tools, including electronic data collection;
- 3. the electronic payment system;
- 4. basic grievance and anti-corruption measures; and
- 5. production of national identification cards to beneficiaries.

These advances in systems-building have been in part due to complementary support from the Rapid Social Response Multi-donor Trust Fund. Using these systems, the Project has identified approximately 3,200 potential beneficiaries for inclusion in the SPRINT. Out of these, approximately 2,720, or 23% of the Project target of 12,000, were enrolled in the SSN cash transfer program in February 2015 and began receiving the first quarterly cash transfer in March. All remaining beneficiaries are expected to be enrolled by the end of 2015.

Beyond successfully rolling out the basic systems and the cash transfers, the Project has made significant progress in institutional strengthening. Staffing for all but one position in the SP Secretariat and NaCSA central and field offices has been completed and the MIS equipment for the SP Secretariat, NaCSA central and field offices, and key sector ministries has been procured. The project has strengthened coordination through support for regular sessions of the SP Inter-Agency Forum and the SP Technical Steering Committee, the highest levels of policy coordination. Due to this enhanced coordination, more resources for safety nets in response to EVD have been mobilized through the Ebola Emergency Response Project. In addition, to support Government's response to the Ebola crisis, at the peak of the outbreak the project reallocated approximately US\$50,000 to support the immediate stabilization and mitigation measures, in particular to conduct information and communication activities and social mobilization in the four targeted districts to help contain the spread of the disease and thus minimize the impacts on extremely poor households. These efforts were implemented NaCSA in September-October 2014 in partnership with the Ministry of Health and Sanitation and benefited 11,600 households. The Project has also supported two rounds of data collection of national high frequency cell phone data, implemented by Statistics Sierra Leone to measure the socioeconomic impacts of EVD to help estimate the country's evolving social protection needs.
