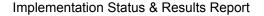

Implementation Status and Key Decisions

The Social Safety Net Project has made substantial progress since its approval on March 25, 2014 and effectiveness on August 29, 2014. Despite challenges due to the Ebola Virus Disease (EVD) outbreak, the Project is on track to achieve its objectives. The Project has operationalized activities under all components, namely systems building, cash transfers, and project management and capacity building. The key systems elements operationalized include:

the three-stage targeting tools (geographical targeting, community-based targeting, and proxy means testing); the management information system (MIS) and integrated registry, the Social Protection Registry for Integrated National Targeting (SPRINT);

related operational tools, including electronic data collection;

the electronic payment system; and

basic grievance and anti-corruption measures.

Through these systems, the Project has identified more than 15,000 potential beneficiaries for inclusion in the SPRINT. Out of these, approximately 13,547, slightly exceeding the original Project target of 12,000, have been enrolled in the SSN cash transfer program. Of these, approximately 2,720 have received the first two quarterly payments in March and June of 2015; another 10,827 are expected to receive the first quarterly transfer in October of 2015. Following the signing of the Additional Financing package, an additional 10,000 beneficiaries were targeted in September-October 2015 as per the Additional Financing design.

The systems put in place by the Project thus far, including the targeting tools and anti-corruption and grievance redress measures, have promoted transparency and fairness in the targeting processes. As the targeting phase of the project has now concluded, continuing to strengthen the systems needed to ensure timely and transparent delivery of payments will be key to the Project's success. This will require continuous learning and improvements in the payment system itself, as well as related systems and tools linked to the payment system, including the management information system, ongoing communication campaigns, the anti-corruption and grievance redress mechanisms , and fiduciary support. The Project is expected to undertake a rapid assessment of the payment system prior to the next mission with a view toward introducing payment system improvements. In addition, the first series of complementary workshops, which will focus on improving beneficiaries' understanding of the program and grievance channels, are expected to take place in December 2015. The Bank team will continue to provide strong support for improving systems as the Project progresses.

The mission also noted the leading role the Inter-Agency Forum (IAF) and the SP Secretariat played in coordinating the social protection response to the Ebola crisis and the importance of continued coordination of these interventions in the recovery process and longer run. The Secretariat has been supporting the application of the targeting tools developed under SSN by partners implementing cash transfer interventions. However, the IAF meetings, which are to be held quarterly according to the SSN project design, have not been held since April 2015. Given the importance of coordination for the project's success, it was agreed that the next coordination meeting would be held by November 15, 2015.

An Additional Financing package of US\$14.3 million (US\$10 million IDA with US\$4.3 million co-financing from the Ebola Recovery and Reconstruction Trust Fund) was approved by the Bank's management on August 6, 2015 and signed on September 18, 2015. The Additional Financing is pending effectiveness, which is expected to be declared by January 2016 upon parliamentary approval and issuance of the legal opinion for the Project.

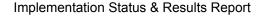

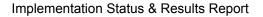

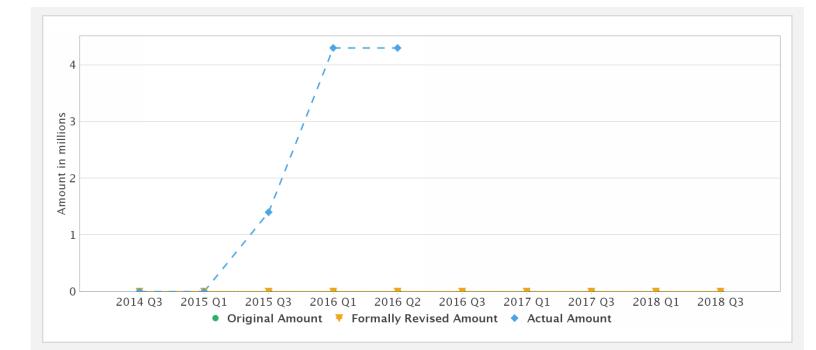
