Support for the implementation of the Central American Trade Facilitation Strategy (D2380)

Description:

This TC will support actions and initiatives that are being developed in Central America and in which the Bank has taken a key position as a strategic partner for the countries and main reference in Trade Facilitation issues. The reference framework that is taken into account for the topics to be developed in this TC is the Central American Strategy for Trade Facilitation and Competitiveness (ECFCC) in which the Bank supported its development in 2014-2015 and which has been executed in the region.

Through official communication, the Secretariat of Central American Economic Integration (SIECA), by mandate of the Council of Ministers of Economic Integration (COMIECO), formally requested support from the IDB for the process of updating the ECFCC, which has been carried out through technical support and financial that aimed to update the ECFCC (ECFCC-2023) through a regional consensus process with the participation of the countries, through key actors. The IDB has been and is the main partner and strategic ally of the region in trade aspects.

The ECFCC-2023 frames the measures and actions to advance trade facilitation, which authorities linked to foreign trade must implement in a coordinated manner, nationally, bilaterally and regionally. The ECFCC-2023 is extended to all modes of transport: air, land and sea. The measures will be implemented based on five pillars, which, in coordination, contribute to the general objective, which is: reduce the costs and times of cross-border trade, maintaining effective controls, and contributing to the reduction of logistics costs and the increase in competitiveness.

The implementation of the ECFCC is a benchmark milestone in Latin America. The scope of this updated instrument includes central elements to strengthen and contribute to improving trade flows, including key concepts that are aligned with best international practices, among which stand out: (i) the implementation of the Coordinated Border Management (GCF) model) in border modernization processes, and which includes double-header or single-header operational integration models; (ii) the implementation of a regional interoperability bus between the countries, which is the Central American Digital Trade Platform (PDCC), which links the national systems of foreign trade processes; (ii) general measures such as: implementation of advance declarations, traceability and regional monitoring mechanisms, measurements of crossing times, among others.

The general objective is to support the implementation of activities established in the update of the Central American Strategy for Trade Facilitation and Competitiveness (ECFCC-2023), giving continuity to the participation of the IDB as the main strategic ally of the region in terms of trade. Specifically, the TC's objectives are to concretely support three areas associated with the

Specifically, the TC's objectives are to concretely support three areas associated with the ECFCC: (i) contribute to the implementation of the measures contemplated in the Strategy, prioritizing the pillars related to the Bank's support to the countries; (ii) support the development of the ECFCC-2023 monitoring and evaluation plan; (iii) support regional dialogue and the achievement of agreements regarding trade facilitation, as well as the dissemination of knowledge products.

In the case of Honduras (GN-2944) it is linked to infrastructure and logistics challenges; in Nicaragua (which does not have an updated Strategy) to initiatives of regional integration and Panama (GN-3055) as support for the recovery and diversification of the economy via greater regional interconnection.

On the other hand, the TC is aligned with the sustainable development challenges of Central America (IDB, 2019) in terms of trade and investment through the facilitation and digitalization of foreign trade as a regional public good. The TC is consistent with the Sectoral Framework for Integration and Trade (GN-2715-11) and is verified by promoting conditions of customs interconnectivity and improving access to information with a view to reducing trade restrictions, therefore reducing information costs, failures of market, coordination and collective action providing added value to national interventions.

The ECFCC-2023 is aimed at contributing to the improvement of trade flows in Central America, for which it is expected to make use of cutting-edge technological tools, such as computer systems for customs risk management, interoperability of information through the Digital Platform of Central American Commerce and other tools that will be developed to improve data management. The scope of interventions proposed by countries is aligned with conditions to contribute to innovation (for example, regulations and e-commerce platforms) that are essential to improve trade flows and exchange in the region.

□ Economic Integration

The ECFCC-2023 contributes to the Central American integration process as it strengthens the coordination of the countries, advancing the standardization of policies, regulations and procedures within the framework of the General Treaty for Central American integration. These processes are supported by the technical management of the Secretariat of Central American Economic Integration as a space for coordination and articulation, in different areas and executing the actions that emanate from the Council of Ministers of Integration of the countries. The IDB has been a strategic partner in the integration process, participating in the main spaces for analysis, policy dialogue and emblematic projects for integration issues.

☐ Institutional Capacity and Rule of Law

The ECFCC-2023 contemplates actions to strengthen the institutions of the countries, contributing not only technical knowledge, but also institutional management in accordance with the nature and scope of each area, taking as reference the best practices and international recommendations. The generation of spaces for dialogue that strengthens regional coordination between countries is promoted, strengthening key entities and institutions related to international trade.
