Dear Alessandro,

Please find below the answers to your questions:

Where the new production facility will be built?

ANSWER: The new dairy processing facility will be built on the same site as the existing dairy processing facility.

Moreover, what types of "climate smart farming practices" will be promoted among Mongolia dairy farmers?

**ANSWER**: These practices include:

- enhanced feed management including balancing feed ration, the procurement high quality feed, supplementary feed provision, etc.
- improved pasture management comprising improved grazing management, rotational grazing, establishment of cultivated pasture, etc.
- herd management enhancement for example via improved veterinary and breeding management
- enhanced farm infrastructure including provision/enhancement of animal shelter, improved feed and manure storage

Were risks along all APU Dairy's supply chain assessed (e.g., workers' rights, animal rights and health)?

**ANSWER:** Supply chain risks were identified and evaluated in accordance with the EBRDs Environmental and Social Policy and the relevant requirements of Performance Requirements 1, 2 and 6.

Have local communities been consulted about the company's expansion plans?

**ANSWER:** Local stakeholders have been informed of the project in the context of national regulatory requirements. Given the relatively limited impact of the dairy expansion no additional consultations have been required.

Is it possible to access the findings of the EBRD's site visits?

**ANSWER**: This is Category B project and information disclosure is therefore limited to the Project Summary Document. Findings from EBRD site visits are not publicly available.
