# 1. Background and Justification

- 1.1 Established in 1959, the Inter-American Development Bank ("IDB" or "Bank") is the main source of financing for economic, social, and institutional development in Latin America and the Caribbean. It provides loans, grants, guarantees, policy advice, and technical assistance to the public and private sectors of its borrowing countries.
- 1.2 In recent decades, countries in Latin America and the Caribbean have faced increasing challenges related to crime and violence. The presence and influence of criminal groups pose a significant threat to the region's development, limiting economic progress, affecting citizen security, and eroding democratic institutions. These groups disproportionately impact vulnerable populations and exacerbate existing inequalities.
- 1.3 The complexity of organized crime and violence, as well as the influence of criminal groups, requires an evidence-based approach to fully understand their dynamics and effects. The region has experienced high levels of crime and violence for years, and the presence of these groups is associated with high economic and social costs. Crime and insecurity have proven to be major obstacles to development, limiting both foreign investment and economic growth.
- 1.4 To address these issues, the Bank considers it crucial to analyze citizens' perceptions and experiences regarding crime, violence, and the presence of criminal groups. This will help to develop effective public policies that allow these challenges to be addressed. In this context, the Americas Barometer, led by Vanderbilt University Latin American Public Opinion Project (LAPOP), is a fundamental tool for collecting this information through surveys in the region.
- 1.5 This project will contribute to identifying the perception of the presence of criminal groups, as well as the impact of violence in the region, by collecting information in Latin America through a survey.

#### 2. Objectives

2.1 This consultancy will fund the preparation and inclusion of survey items in the 2025 wave of Americas Barometer survey in the Latin American region, with a specific focus on public sentiments and experiences with the role of crime, violence, and the influence of organized crime groups.



# 3. Scope of Services

The consulting firm's services will focus on:

- 3.1 Preparation of the survey plan for 2025.
- 3.2 Review of questions related to crime, violence, and the influence of organized crime groups used in the past.
- 3.3 Preparation of the survey instrument to be implemented during the Americas Barometer 2025 round.
- 3.4 Data collection.

#### 4. Key Activities

The consulting firm shall carry out the following activities:

- 4.1 Preparation of the survey plan for 2025.
- 4.2 Review of questions related to crime, violence, and the presence of organized crime groups that have been used in the past.
- 4.3 Preparation of the survey instrument to be implemented during the Americas Barometer 2025 round.

#### 7. Acceptance Criteria

- 7.1 The acceptance of products derived from these terms of reference will be based on compliance with clear and defined criteria. The delivered products must meet the following criteria:
- The databases will be delivered anonymized, harmonized and unified with unique individual identifiers for each observation unit (geographical areas, police sections and/or individuals, as appropriate). If applicable, the individual identifiers must allow the merging of the different bases.
- The databases submitted must be accompanied by a metadata document and dictionary of variables. This document must contain the information related to the variables included in the database; name and label of variables (linking them to the corresponding question in the data collection instrument, if applicable); name, labels and scales of the responses; and all the information necessary to effectively understand and analyze the data contained in the variables submitted.
- The final databases should be accompanied by a document with a detailed description of the framework and sample design, including information on weights, representativeness, and methodologies used in data collection and processing.
- 7.2 The acceptance of each product will be carried out by the IDB's Research Department and the Citizen Security and Justice team. Products will be evaluated on their compliance with the established quality criteria and will only be considered as accepted after formal approval by the designated managers.

# 8. Consulting Company and Key Team Requirements

- 8.1 The selected consulting firm must have extensive experience in conducting public opinion studies in Latin America and the Caribbean:
- Extensive experience in the design and implementation of surveys in Latin America, highlighting their regional coverage, and the inclusion of victimization questions.
- It is key that the company is implementing a public opinion survey with broad coverage in 2025, allowing the inclusion of a specific module on this topic.
- Proven ability to manage large-scale research projects, including multidisciplinary teams and development of robust sampling frames.
- Ability to add specific modules and take advantage of the rest of the questions included, maximizing the value of the information obtained.

#### 1. Background and Justification

- 1.1. Established in 1959, the Inter-American Development Bank (IDB) is the leading source of financing for economic, social, and institutional development in Latin America and the Caribbean. The Bank provides loans, grants, guarantees, policy advice, and technical assistance to support sustainable development.
- 1.2. In recent decades, the Caribbean has faced escalating challenges from organized crime and violence, which threaten citizen security, erode democratic institutions, and impede economic progress. Criminal groups disproportionately impact vulnerable populations, exacerbate inequality, and impose significant social and economic costs, including reduced foreign investment and weakened public trust in institutions.
- 1.3. The complexity of organized crime necessitates a strategic, evidence-based approach, with criminal justice reform as a cornerstone. The CCJ Academy for Law (CAL) plays a pivotal role in advancing this agenda through initiatives like the Needham's Point Declaration on Criminal Justice Reform. By addressing critical gaps in judicial systems and promoting transparency and efficiency, CAL's reforms directly contribute to reducing the influence of organized crime. The establishment of the Monitoring, Evaluating, and Facilitating Committee (MEFC) underscores CAL's commitment to tracking the implementation of these reforms across the region. This consultancy is vital to operationalize these efforts, fostering accountability and collaboration among stakeholders to create more resilient justice systems and mitigate the pervasive impacts of organized crime.

#### 2. Objectives

2.1. The objective of this consultancy is to strengthen the capacity of criminal justice institutions in the region to monitor improvements in criminal justice processes and outcomes at the regional level, with an emphasis on serious and organized crime. This consultancy will entail a gap analysis of investigative, prosecutorial, defence, judicial, and custodial processes and development of recommendations to craft a robust regional monitoring, evaluation, and reporting framework to track judicial process outcomes and inform decision-making on future reforms at a regional level.



#### 3. Scope of Services

3.1. Consultancy category and modality: Individual Consultant

Estimated duration: Four (4) month period

Place(s) of work: Country of the consultant.

- 3.2. The consultant will be required to collaborate with CAL and assess the reporting gaps and redundancies within current national regimes for capturing information on investigative and judicial processes related to serious and organized crime. This diagnostic assessment should yield a clear description of how to improve deploying and managing a robust regional monitoring, evaluation, and reporting framework to track judicial process outcomes ranging from report intake to rehabilitative and reintegrative processes.
- 3.3. Through close cooperation with key stakeholders in the criminal justice sector, the consulting firm must produce a summative report with recommendations on regional monitoring, evaluation, and reporting framework to track judicial process outcomes, that facilitates improved incident- and summative-reporting, case tracking and data sharing with existing and impending criminal justice case management data collection systems. At a minimum, the recommendations must speak to the resources needed, be they finances, personnel or technology, to implement and maintain said framework as well as the appropriate governance structure to ensure sustained, inter-agency coordination.

# 4. Key Activities

- 4.1. Develop protocols and templates for field research to guide the collection of quantitative and qualitative data to better understand (i) the reporting and investigation of serious and organized crimes; (ii) court administration processes and user requirements for databases with data related to serious and organized crime; (iii) the use of bespoke legislation such as proceeds of crime, whistleblower, and asset recovery laws in the prosecution of cases involving serious and organized crime; and (iv) serious and organized crime case outcomes.
- 4.2. Engage, sensitize and supervise court users and administrative personnel to gather and share information on their administrative data collection processes to ensure standardized reporting on institutional gaps for effective monitoring, evaluation and reporting of judicial process outcomes.
- 4.3. Assess the current administrative and operational arrangements for collecting data on serious and organized crime to determine the main factors contributing to the underreporting of case processes and outcomes. This initial assessment should specify where deficits exist regarding, but not limited to, the following areas:
  - Hardware/software equipment;
  - Data flows and administrative protocols for centralizing the data;
  - Personnel training and competencies;
  - Use of data analysis for strategic and operational decision making;
  - Compatibility of crime reporting forms currently in use; and
  - Information security management.



- 4.4. Produce recommendations and a costed action plan that justify suitable approaches for maintaining an effective regional monitoring, evaluation, and reporting framework to track judicial process outcomes and inform decision-making on future reforms at a regional level database including the appropriate governance structure (eg location(s) and oversight responsibility); detailed descriptions of business processes to be reengineered; alignment with existing crime reporting databases within the region; storage requirements; potential software solutions; training needs and security protocols. These recommendations should consider the feasibility and utility of possible capacity upgrades to a database based in CAL such as:
  - Exists online with a preference for open-source language in its programming, while complementing the current regime of paper-centric reporting.
  - Facilitates data entry by service providers, access to data modules for end users and management of the system by administrators, within an appropriate and secure authorization scheme.
  - Uses offense and relationship codes that are compatible with international incident-based crime reporting systems.
  - Provides for data analysis based on relevant disaggregations such as geography, age, gender, nationality, ethnicity, religion, marital status, and employment.
  - Allows for monthly/annual validation and presentation of data using appropriate tools such as fact sheets, GIS maps or dashboards; and
  - Accommodates data sharing and integration with complementary or superordinate databases within the criminal justice sector, whether in existence or pending.

#### 5. Expected Outcome and Deliverables

- 5.1. The consultant shall prepare and submit the following in Dutch and English:
  - Inception Report and Work Plan
  - Diagnostic Assessment
  - Final report with recommendations and action plan

#### 1. Background and Justification

- 1.1. The mission of the Institutions for Development (IFD) Sector within the IDB is to strengthen public institutions by improving public management, strengthening justice and citizen security, promoting innovation and strengthening the private sector and value chains, improving connectivity and digital inclusion, and the operations of the financial markets of our member countries in Latin American and the Caribbean.
