Implementation Status and Key Decisions



With the Higher Education Project (HEP) launched, the Ministry of Education and Science (MoES) is making progress in filling several key project roles, including the Project Coordinator and Consultant for Financial Management. The Bank encourages the MoES to move swiftly with its selection and hiring process.

The Bank team received a complaint from civil society regarding the selection process for the Project Coordinator. Noting that the selection process for the Project Coordinator is ongoing, the MoES responded to the concerns expressed in the complaint, and the matter is considered closed.

The MoES still needs to establish an Inter-Ministerial Steering Committee, as stipulated in the financing agreements, to launch the Just-in-Time grants program detailed in Sub-Component 1.1. This was to be established on or about May 29, 2016.

The MoES still needs to finalize and adopt a Grievance Redress Mechanism acceptable to the Bank. According to the financial agreements, this was to be done by the end of April.

The MoES has not established a Designated Account (DA) for the HEP.
