(2) Improve coverage and quality of social services and strengthen monitoring of outcomes.

Implementation Status and Key Decisions

Early results and dialog with the authorities indicate that some progress has been made in achieving the development objectives outlined in the Inclusive Growth DPF for Georgia. These include availability of budget and execution data for municipalities, legal entities of public law and non-profit legal entities on a real time basis, availability of financial data on SOEs, and improvements in maternal mortality rates. While progress on policy reforms have been encouraging in the education sector and in the framework for civil services, others like the public investment guidelines and reforms in the targeted social assistance (TSA) program have shown slower progress. However, initial data indicate that the outcome indicators associated with this DPF series are likely to be achieved by the target date of end-2017. The program is being implemented in close collaboration with the IMF.

As a result of slow progress on some of the policy fronts and a deterioration in the overall macroeconomic framework, the team agreed with the government that once all policy actions for DPL2 are met, an agreement is reached on the modifications required on the targeted social assistance and there is sufficient clarity on the fiscal performance, DPL2 would be presented to the World Bank's Executive Board in July 2016. Based on discussions with the authorities, an agreement on the TSA modifications and completion of all prior actions for DPL2 is likely by mid-March 2016. However, greater clarity on the fiscal outcome for 2016-17 could take longer. The change in the DPL2 timeline will also impact the timeline for DPL3 which will be presented to the Board 12 months after the DPL2 Board date.
