Amendment to Grant Agreement

Excellency:

We refer to the Grant Agreement (“Agreement”) dated August 26, 2016 between the Kingdom of Cambodia (“Recipient”) and the International Development Association (“World Bank”), acting as administrator of the above referred Multi-Donor Trust Fund (“Trust Fund”) for the Cambodia Health Equity and Quality Improvement Project (“Project”).

The World Bank proposes to amend the Agreement to increase the amount of the Grant made available to the Recipient by an additional sixteen million five hundred thousand United States Dollars (U.S. \$16,500,000). This increase reflects additional contributions received from the Trust Fund donors in accordance with Article III, Section 3.03 of the Agreement. Accordingly, the Agreement is amended as set out below:

1. Article III, Section 3.01 of the Agreement is amended to increase the Grant amount by sixteen million five hundred thousand United States Dollars (U.S. \$16,500,000) as follows:
 - “3.01. The World Bank agrees to extend to the Recipient, on the terms and conditions set forth or referred to in this Agreement, a grant in an amount equal to twenty million Dollars (\$20,000,000) (“Grant”) to assist in financing the Project.”

2. The withdrawal table in Section II.A.2 of Schedule 2 to the Agreement is amended as follows:

(3) Eligible Expenditure Programs under Part 3.1 of the Project	4,500,000	100 % of the Grant's agreed share of the cost specified in the approved AOP for each FY
(4) Goods, works, non-consulting services, consultants' services, Operating Costs and Training under Parts 3.2 and 3.3 of the Project	1,500,000	100 % of the Grant's agreed share of the cost specified in the approved AOP for each FY
TOTAL AMOUNT	20,000,000	

Except as specifically amended by this letter of amendment, all other provisions of the Agreement shall remain unchanged and in full force and effect.

Please confirm your agreement with the amendments set out above by countersigning, dating and returning to us the enclosed copy of this letter of amendment. Upon receipt by the World Bank of the countersigned copy of this letter of amendment, this letter of amendment shall become effective as of the date of countersignature.
