## Implementation Status and Key Decisions

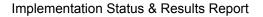
Implementation of the project activities remains fully relevant for the country and sector context. Overall, implementation since project effectiveness (June 2015) has progressed relatively well and received strong support from both the Central level and Oblast level.

The priority since the project became effective has been the setting up of the implementation structure and the strengthening of the technical and fiduciary capacity. By now, the Project Implementation Units at both the central level and Oblast level are functional, and key consultants (subproject coordinators, procurement specialists and financial managers) are in place. Training and workshops on fiduciary, M&E, Governance were conducted and targeted technical support to the Oblasts were also provided. An action plan to intensify the preparation and processing of key procurement packages by the Ministry of Health and project Oblasts has been formulated and agreed. Together with the enhanced implementation capacity, the implementation pace is expected to improve. Additional efforts have been made to protect the project from integrity risks and to ensure the project funds are used for intended purposes.

Modest improvement is seen in the indicator of early detection of cervical and breast cancer, which can be attributed to the improved awareness of the population about the available screening services as an outcome of placement of information and educational materials, thematic TV sessions dedicated to the cancer theme in Lviv region.

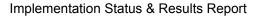

Several project activities have contributed to this positive trend, including better assessment of patients at risk and high blood pressure management, leading to prevention of unnecessary hospitalizations. A significant raise is seen in the number of patients who received stenting as a result of giving higher priority to timely treatment of patients with acute myocardial infarction.

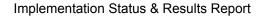

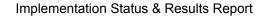
The number reflects civil works financed by the local budgets; the major renovation, construction and equipment packages planned within the project are being processed.

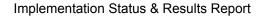

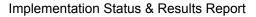
The value is to be received from the survey of project beneficiaries, which[JA1] is being developed. The bidding process is expected to be announced in spring 2016.

#### **Overall Comments**

The results are reported based on data received from 8 pilot oblasts and on all subcomponents of the second and third components of the Project. However, to calculate the indicators No 3a, 4, 13 of the Project's Results Framework, data from the remaining 16 oblasts of Ukraine and Kyiv city, as well as institutions of departmental subordination are needed. To date, these inputs have not yet been processed and provided by the Centre of Medical Statistics of the MoH, consequently, these indicators will be updated later.

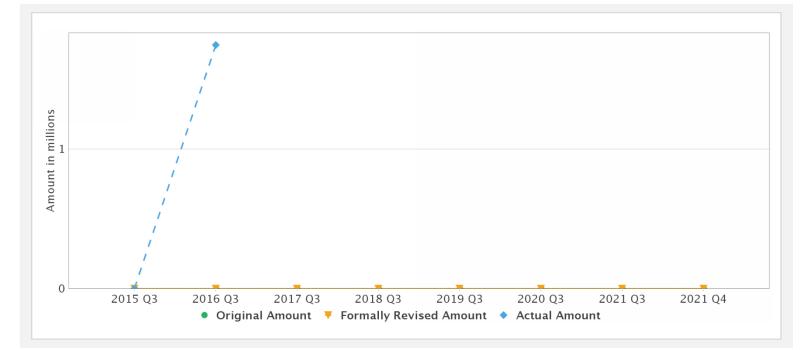
