
This ISR covers the period January-June 2012.

The loan was declared effective on November 25, 2011. Implementation has been on-going nonetheless for part of 2010 and most of 2011 under the retroactive financing window. During this period, activities corresponding to a total investment of 192.5M pesos (14.5M USD) have been implemented.

For 2012, CONAGUA has prepared a proposal of 17 projects in 6 different municipalities representing a total of 124M pesos to be financed under Component 2 as well as a list of


