## Implementation Status and Key Decisions

EITI implementation during 2015 is overall satisfactory. After the suspension of its candidacy status in February 2015, Tajikistan accelerated EITI implementation and achieved tangible results with the production of its first EITI National Report for calendar year 2014. It recovered its candidate status in November 2015, organized several communication and capacity building workshops with various stakeholders to promote and raise EITI awareness in the country. Over 93% of the original grant of \$300k was disbursed by December 2015.

An additional financing of \$200K was provided to Tajikistan, and its EITI grant closure date extended to October 31, 2017. This additional financing will support the validation process, capacity building, the EITI report for 2015 and its dissemination, etc..

A validation working group was formed and developed the Validation Readiness Analysis Report to highlight areas needing corrective actions to enable a good validation process during the summer of 2016. Selected activities useful to EITI are foreseen including the Beneficial Ownership Road Map, assessments of artisanal and small scale mining, and of economic and social contributions of mine operations at the subnational level.

- (i) Workshops for companies' accountants and employees of state agencies on EITI data provision
- (ii) Training on preparation to the validation activity for EITI stakeholders
- (iii) Holding EITI National Conference to present the First EITI National Report for calendar 2014
- (iv) Study tour for EITI National Council members to learn and exchange experience with Kazakhstan and Kyrgyzstan EITI Stakeholders.


