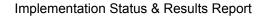

Implementation Status and Key Decisions



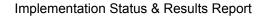


La Asemblea Legislativa Plurinacional approved the project as Ley 799 and Ley 800 on 25 April, 2016 (IBRD and IDA respectively). Reportedly, the subsidiary agreement between borrower and implementing entity (ABC) is in preparation and effectiveness should be expected soon. Implementation support mission is planned tentatively for July 2016.


