



Implementation Status and Key Decisions

This ISR is based on a supervision mission that took place between April 18 and 22, 2016. The Project was approved by the Bank on September 23, 2015, signed on December 18, 2015 and declared effective on April 18 2016. The Project has not started disbursements due to the processing of an extraordinary budgetary allocation for CY 2016. Most of the progress in Project activities has been carried out by MIDES with own resources and technical assistance from the World Bank and other international organizations. Despite the limited budgetary affecting the start of activities, implementation is assessed as satisfactory.

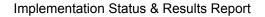




