C. Summary Description of Proposed Project [including overview of Country, Sectoral & Institutional Contexts and Relationship to CPF]

Although this financing has been prepared as a stand-alone project, this is due to a change in the World Bank's rules which requires all projects to be prepared using the recently development Environmental and Social Framework (ESF). (The ongoing Quality Education for All Project – PEQT was prepared and approved prior to the new ESF rules.) However, preparing this grant together with the tools under the new ESF provides an opportunity to assess and then begin to tackle key issues such as GBV and inclusive education which were not done under the original IDA and GPE financed project.)



Given the limited amount of financing and the extremely fragile and challenging context for implementation, strong efforts were made to selective in the number of new activities. Rather than overload the Ministry with many new activities while they are still struggling with efforts already underway, attention was given to identify activities that will help to address the existing implementation challenges and would have the greatest potential to ensure success of the current project and build MENES' capacity. Although frequent changes in personnel make capacity building efforts challenging, setting aside sufficient funds to provide training for more technical staff who often remain after regime changes is essential for sustainability. Project activities focus on (i) strengthening institutional capacity; (ii) improving planning and using education data to manage resources; and (iii) starting initiatives to strengthen citizen engagement and addressing gender norms.

D. Environmental and Social Overview

D.1. Detailed project location(s) and salient physical characteristics relevant to the E&S assessment [geographic, environmental, social]

This project will be implemented at the national level where technical assistance activities will take place in Bissau, Cacheu, Bafata, Oio, and Quinara. No salient geographic, environmental or social features are relevant as the proposed activities will be organized in easily accessible locations outside any environmentally sensitive areas. D. 2. Borrower's Institutional Capacity

Borrower capacity on environmental and social risk management in Guinea-Bissau are fairly limited but through a number of recent training activities on different aspects of the ESF a cadre of specialists is slowly emerging in various PIUs. The PIU responsible for the sister project (Quality Education for All, P160678), is expected to oversee this project and would be responsible for, with this new grant, recruiting an SDS to help support the development and implementation of ESF related documents, the development of the GRM and cover citizen engagement and SEA/SH issues. The performance of the PIU has been consistently rated as Satisfactory.

II. SCREENING OF POTENTIAL ENVIRONMENTAL AND SOCIAL (ES) RISKS AND IMPACTS

A. Environmental and Social Risk Classification (ESRC)

Environmental Risk Rating

The project is not expected to have any adverse environmental impacts as the activities are of technical assistance, therefore the environmental risk is low. The project aims to strenghten the education sector, through improving the national monitoring system of the education sector and strenghtening the insitutional capacity within MENES. Once robust dataset and mapping of school systems are available the project will support activities such as training for school directors and administrators, the purchase of shelves, storage cabinets, etc. for the schools targeted by PEQT. The project will not support any civil work contructions. The environmental risks expected are the generation of some amount of solid waste from the distribution of school furniture such as shelves, storage cabinets, etc. but are likely to be minimal or negligible. Other risk includes Occupational Health and safety of project workers and beneficiaries because of the risk of spread of COVID-19 during meetings and trainings supported by the project.

This standard is applicable, as the labor force for this project only consists of the PIU staff and a number of consultants. Given the scale of project activities, there is no need to prepare LMP but the ESCP will include some basic commitments on labor and working conditions, such as safety and health at work including those related to COVID-19 pandemic. In addition, current Occupational Health and Safety protocols of the PIU will be updated to protect its staff and consultants.

No building or construction will take place, only procurement of school materials and furniture (shelves, storage cabinets, etc.) to targeted schools that might generate some waste but expected to be minimal or negligible. Therefore, this standard is currently not applicable.
