The project will support a regional approach to public procurement monitoring & evaluation (M&E) in Botswana, Eswatini, Lesotho, and Namibia based on an umbrella M&E framework developed on the basis of general and country-specific M&E indicators to measure procurement policy objectives, performance, and compliance. It will also focus on building M&E capacity of the public procurement regulatory authorities and procuring entities in the 4 countries.

D. Environmental and Social Overview

D.1. Detailed project location(s) and salient physical characteristics relevant to the E&S assessment [geographic, environmental, social]

The grant will support the development of an Monitoring and Evaluation (M&E) framework (Type 2 TA) in Botswana, Eswatini, Lesotho and Namibia. The M&E framework will play an important role in monitoring progress towards enhancing good governance, transparency, and accountability in the four countries and ultimately contributing to better development outcomes. The development of the Monitoring and Evaluation framework is not foreseen to have any environmental and social impacts and more likely to potentially lead to strengthening of procurement processes to benefit the environment (green sustainable procurement) and social aspects. The grant will further support development and improving of the public procurement M&E capabilities (Type 3 TA) of key stakeholders in the four countries to enhance their effectiveness in monitoring country programs and inform strategic public procurement planning while also supporting the strengthening of institutional capacity for evidence-based policy making. The grant will only finance Type 2 and Type 3 technical assistance with limited to no downstream adverse environmental and social impacts.

D. 2. Borrower's Institutional Capacity

The implementing agency will be the Southern African Development Community (SADC), who will be responsible for the development of the Public Procurement umbrellas M&E framework based on international expertise and experiences and subsequent customization for each of the four country contexts. SADC will further be responsible for coordinating regional training for the Public Procurement Regulatory Authorities in the four countries as well as training for relevant stakeholders. SADC has prior experience of implementing Bank funded projects under the Groundwater management in SADC member states project (P175355) and (P127086). The environmental and social aspects of both projects rated as satisfactory. The responsibilities of overseeing the environmental and social aspects under this TA will be assigned to a designated person within SADC.

The environmental risk is considered low. The grant will support the development of a procurement monitoring and evaluation framework and therefore will have no physical footprint. The grant will further support capacity building to strengthen public procurement processes, management of resources effectively and to reinforce fair and reliable delivery of public services while enhancing evidence-based policy making. The development of the procurement monitoring and evaluation framework is likely to enhance environmental considerations by measuring aspects such as green sustainable procurement to address environmental impacts (ESS1) associated with procurement and considering aspects of resource efficiency and pollution prevention (ESS3). General occupational health and safety

and working conditions relevant to the project will be apply as set out in the Environmental and Social Commitments Plan.

Social Risk Rating Low

The social risk is considered low. The grant will support the development of a procurement monitoring and evaluation framework and therefore will have no physical footprint. The grant will only finance technical assistance activities. Consultant services and outputs under this grant are not expected to have any adverse downstream social risks and impacts. General occupational health and safety and working conditions relevant to the project, as well as labor issues, will be apply as set out in the Environmental and Social Commitments Plan (ESCP). Given that activities will eventually benefit four countries, stakeholder engagement will be important. Key elements of ESS10 will be reflected in the ESCP. Grant activities will support coordination capacity of SADC (implementing entity) for necessary outreach to government stakeholders in four countries. GBV/SEA/SH risks are deemed low, mostly due to small scale of the project activities and the fact that it will not finance any works.

Overview of the relevance of the Standard for the Project:

The activities supported under the grant are expected to have minimal or negligible risk to and impact on the environment and social. The activities supported under the grant will not have any physical footprint. Risk related to labor and working conditions and occupational health and safety (ESS2) for all project workers will be mitigated through measures included in the Environmental and Social Commitment Plan (ESCP).

Areas where "Use of Borrower Framework" is being considered:

The use of borrower framework is not being considered for this project.

ESS10 Stakeholder Engagement and Information Disclosure

The objective of the stakeholder engagement is to incorporate views from all stakeholders through meaningful consultations and feedback, improve the environmental and social sustainability of the project, enhance its acceptance, and make a significant contribution to successful project design and implementation. The main stakeholders for this grant include SADC itself, as well as relevant agencies responsible for procurement aspects from four countries. Stakeholders may also include local governments at the respective localities and civil society organizations (CSOs). Methods of outreach to main stakeholders and key requirements of ESS10 will be reflected in the ESCP and there will be no stand-alone SEP. ESCP provisions will be proportionate to low E&S risks given the nature of TA activities.

The standard is considered to be relevant as the activities are anticipated to be executed by direct workers (civil servants) and contracted workers (consultancy firms). All requirements of ESS2 will apply to the contracted (consultant) workers. Project implementation responsibilities will be assigned to existing SADC employees who will remain under SADC employment and will not be legally transferred to the project. These employees will remain subject to the terms and conditions of their existing employment agreements with SADC, and therefore the application of ESS2 is limited to the child and forced labor and occupational health and safety requirements. The World Bank standard procurement and contracting for the consultancy firm which reflects ESS2 requirements will be utilized for procuring consultants. Key aspects of Labor Management including occupational health and safety will be included in the ESCP.

ESS3 Resource Efficiency and Pollution Prevention and Management

The standard is not considered relevant. The preparation of the procurement monitoring and evaluation framework is likely to enhance environmental considerations by measuring aspects such as green sustainable procurement which will support aspects of ensuring resource efficiency and pollution prevention (ESS3).
