### **Project Description**

#### **DESCRIPTION**

Tranche 2 will continue improvements in coverage and operational sustainability of Kolkata Municipal Corporation's sewerage, drainage, and water supply services. The accompanying TA will strengthen climate resilience of Kolkata through improved planning and disaster risk management.

### PROJECT RATIONALE AND LINKAGE TO COUNTRY/REGIONAL STRATEGY

The impact of Tranche 2 will be improved access to water supply and sanitation in KMC's service areas (defined by the Investment Program). The outcome will be service quality, operational sustainability, and climate resilience in water supply and sewerage and drianage in the service areas of KMC increased.

#### **IMPACT**

Access to water supply and sanitation in the service areas of Kolkata Municipal Corporation improved.

#### CONSULTING SERVICES

An estimated 733 person-months input of national consultants is required under Project 2 to (i) facilitate project management and implementation, and (ii) strengthen the institutional and operational capacity of the PMU and executing agency. Consulting firms will be engaged using the quality- and cost-based selection method with a standard quality cost ratio of 80:20.

#### **PROCUREMENT**

All procurement of goods and works will be undertaken in accordance with ADB's Procurement Guidelines (2015, as amended from time to time).

International competitive bidding procedures will be used for civil works contracts estimated to cost \$40 million or more, and supply contracts valued at \$1 million or higher. Shopping will be used for contracts for procurement of works and equipment below \$100.000.

Master bidding documents for national competitive bidding (NCB) works was prepared for e-tendering and reviewed by ADB, which will be used throughout Project 2 implementation period for procurement under NCB. ADB and the government have reviewed the public procurement laws of the central and state governments to ensure consistency with ADB's Procurement Guidelines (2015, as amended from time to time).
