#### **Project Description**

According to the bank's website, "The Vanuatu Interisland Shipping Support Project (VISSP) was approved as Loan 2820/Grant 0273-VAN on 30-Nov-11. The project is co-financed by the Government of New Zealand. The safeguards categorizations of the original project are B for environment and C for involuntary resettlement and indigenous people. The project has been under implementation since 2012 and regular review missions have been conducted and semi-annual monitoring reports have been regularly received and disclosed.

Component 1 of VISSP - construction and rehabilitation of domestic wharves and jetties in Vanuatu - originally comprised seven subprojects (Figure 1) including:

- a. South Paray domestic wharf and channel construction
- b. Simonsen wharf rehabilitation
- c. Lenakel wharf rehabilitation
- d. Litzlitz wharf rehabilitation
- e. Lolowai jetty construction
- f. Loltong jetty construction
- g. Port Sandwich jetty construction"
