## **Project Description**

### **DESCRIPTION**

The proposed project will support the economic development of Trincomalee and the eastern region of Sri Lanka by fostering economic activities and improving urban services in Trincomalee. It comprises (i) physical investments to improve urban services in Trincomalee town; (ii) non-physical investments to develop a Master Plan for the region and more specifically for the special economic zone (SEZ) to promote private investment and business; and (iii) non-physical investments to support project implementation and capacity development of urban institutions.

### **PROJECT RATIONALE AND LINKAGE TO COUNTRY/REGIONAL STRATEGY**

The Trincomalee Integrated Urban Development Project (TIUDP), in line with ADB's water and urban operational plans, will (a) improve urban services in Trincomalee town through investments and institutional strengthening; and (b) boost economic development through integrated planning, institutional support and strategic investments in economic infrastructure with wider economic benefits for the future Trincomalee Metropolitan Urban Development Area (TMUDA). The project will facilitate the TMUDA to become a hub of the North Central Metropolitan Region in line with government's vision for the Eastern Province.

### **IMPACT**

Improved competitiveness of the TMUDA.

### **OUTCOME**

Improved access to urban services and enabling environment for economic infrastructure in the TMUDA.
