Project Description

According to ADB website, ADB is helping the People's Republic of China develop an efficient, safe, and affordable multimodal transport system in Anhui province. The project will upgrade provincial and national highways, develop highway sections designed to support public and nonmotorized transport, improve the inland waterway network's capacity, construct an intermodal inland river port, and build institutional capacity. The project will:

1. Upgrade sections of provincial and national highways in Anhui Province and improve the safety features on these roads
2. Develop new highway sections designed to support public and nonmotorized transport
3. Improve the capacity of the province's inland waterway network
4. Construct an intermodal inland river port on the upgraded inland water channel
5. Strengthen institutional capacity for road and inland water transport
