### **Project Description**

According to bank documents, the TA is aligned with ADB's Strategy 2020; the Southeast Asia Department's Climate Change Implementation Plan; and various sector assessments, strategies, and road maps prepared as background to the new country partnership strategy, 2014–2018. The TA supports ADB's Cambodia country partnership strategy, 2011–2013, which aims to reduce poverty and promote inclusive growth with an integrated approach to rural development, targeting the areas where most poor reside. At the same time, it will also be consistent with social protection measures, community-based development, and public sector capacity development.

The impact will be improved national capacity to manage disaster risks in Cambodia.
