The program supports lending for projects done by the Indian Renewable Energy Development Agency. Private capital is being used to increase lending for at least 10 renewable energy projects and to pay for project finance training for government officials.

Financial intermediaries include insurance, pension and equity funds. The direct financial relationship is between the development bank and the financial intermediary.
