Project Description

This project finances the rehabilitation of a 50km road stretch from Dzirula to Chumateleti, via Kharagauli. The road will be upgraded to a two-lan all-weather standard, including several short access roads to the nearby national park, Kharagauli, and other railway stations.

This project road connects Kharagauli to the East West Highway, an integral part of the 4 Central Asia Regional Economic Cooperation (CAREC) corridors.
